## PREFATORY STATEMENT

PRESENTED to the Twelfth Sangguniang Panlungsod ng Ormoc for consideration is an Indorsement dated September 2, 2011 from the Office of the City Mayor relative to the request of Dr. Nelita D. Navales. City Health Officer II, City Health Department, for Reversion of Appropriation in the amount of ONE HUNDRED THOUSAND PESOS (P 100,000.00) to be taken from the account – CY 2010 Capital Outlay - Furnitures and Fixtures to supplement the appropriation for Motor Vehicle of said office.

The City Budget Officer, issued a Certification dated September 1, 2011 with the information that the sum of ONE HUNDRED THOUSAND PESOS (P 100,000.00) is available to supplement the Capital Outlay – Motor Vehicle of the aforementioned Office, which may be taken from out of the reversion of their continuing appropriation – Furnitures & Fixtures, CY 2010.

Furthermore, the City Treasurer, through a Certificate of Availability of Funds dated September 2, 2011 certified that funds are available from the reversion of Continuing Appropriation-Furniture and Fixtures, CY 2010 of City Health Department, which maybe used as funding source to supplement the account Capital Outlay – Motor Vehicle of same office.

RESOLVED, to enact:

## APPROPRIATION ORDINANCE NO. 2011-018 (General Fund)

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P 100,000.00) TO SUPPLEMENT THE APPROPRIATION FOR CAPITAL OUTLAY – MOTOR VEHICLE OF THE CITY HEALTH DEPARTMENT TO BE TAKEN FROM OUT OF THE REVERSION OF CONTINUING APPROPRIATION – FURNITURES AND FIXTURES, CY 2010 OF SAME OFFICE.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. <u>2011 GENERAL FUND SUPPLEMENTAL BUDGET</u>. The sum of ONE HUNDRED THOUSAND PESOS (P 100,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated to supplement the above-mentioned request of the City Health Department to be taken from out of the reversion of Continuing Appropriation – Furnitures & Fixtures, CY 2010 of same office.

SECTION 2. <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer, to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, October 13, 2011.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to His Honor, the City Mayor Eric C. Codilla, the City Administrator, the City Health Officer II, Dr. Nelita D. Navales, the City Treasurer, the City Budget Officer, the City Accountant, the City Auditor, and other offices concerned;

CARRIED by Nine (9) Affirmative Votes with One (1) Abstention registered by Honorable Claudio P. Larrazabal. Honorable Jose C. Alfaro, Jr. was out of the Session Hall during the voting.
