AN ORDINANCE APPROPRIATING THE AMOUNT OF TWO MILLION PESOS (P2,000,000.00) TO SUPPLEMENT THE APPROPRIATION FOR ELECTRICITY - PUBLIC BUILDING ACCOUNT OF THE ORMOC CITY SUPERDOME TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2010.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET.
