PREFATORY STATEMENT

PRESENTED to this Sanggunian for consideration is an indorsement dated November 14, 2011 from the Office of the City Mayor in connection with the letter-request of Mrs. Adelaida H. Biacolo, HRMO IV, for a supplemental appropriation in the amount of THREE HUNDRED SEVENTY EIGHT THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS & 48/100 (P378,878.48) for the payment of Retirement Gratuity (LGU Share) of Mr. Bibiano T. Payod, Agricultural Technologist, CASO, who is a devolved employee from the Department of Agriculture.

Mr. Payod has retired from the government service effective March 1, 2011.

Relative thereto, the City Budget Officer through a Certification dated November 14, 2011 certified that funds are available from the Unappropriated Surplus, End of Year 2010, which amount may be used for the payment of Retirement Benefits (LGU Share) of Mr. Bibiano T. Payod;

Furthermore, the City Treasurer also issued a Certification dated November 14, 2011 stating therein that the sum of THREE HUNDRED SEVENTY EIGHT THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS & 48/100 (P378,878.48) are available to cover the retirement benefits of Mr. Payod as requested by the HRM Officer to be taken from the Unappropriated Surplus, End of Year 2010.

FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Ruben R. Capahi, Chairman, Committee on Finance and Appropriation, jointly seconded by City Councilors Rolando M. Villasencio and Lea Doris C. Villar; be it

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2011-022
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE HUNDRED SEVENTY EIGHT THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS & 48/100 (P378,878.48) FOR THE PAYMENT OF RETIREMENT BENEFITS (LGU SHARE) OF MR. BIBIANO T. PAYOD, AGRICULTURAL TECHNOLOGIST, CASO, THIS CITY, TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2010.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of THREE HUNDRED SEVENTY EIGHT THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS & 48/100 (P378,878.48) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the payment of retirement benefits of the abovementioned employee to be taken from out of the Unappropriated Surplus, End of Year 2010.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;




