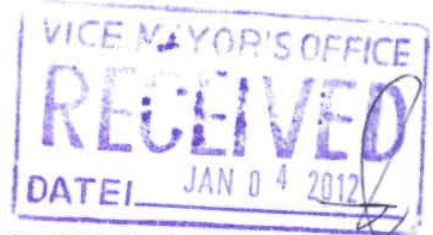

PREFATORY STATEMENT

PRESENTED to this Sanggunian for consideration is an indorsement dated November 24, 2011 from the Office of the City Mayor in connection with the letter request of OIC-City Engineer Raulfo D. Oliveros for a supplemental appropriation in the amount of TEN MILLION PESOS (P10,000,000.00) for the the construction of the Ormoc City Fire Station Building.

The said project is considered one of the priorities of the city hence, favorable action is being proposed.

The City Budget Officer through a Certification dated November 24, 2011 certified that funds are available from the Unappropriated Surplus, End of Year 2010, which amount may be used to finance the construction of the proposed Ormoc City Fire Station Building.

Furthermore, the City Treasurer also issued a Certification dated November 24, 2011 stating therein that the amount above requested in the sum of TEN MILLION PESOS (P10,000,000.00) are available to fund the said priority project as requested by OIC-City Engineer Oliveros to be taken from the Unappropriated Surplus, End of Year 2010.

FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Ruben R. Capahi, Chairman, Committee on Finance and Appropriation, jointly seconded by City Councilors Corinne M. Corro and Jose C. Alfaro, Jr.; be it

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2011- 026  
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF TEN MILLION PESOS (P10,000,000.00) FOR THE CONSTRUCTION OF THE PROPOSED ORMOC CITY FIRE STATION BUILDING TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2010.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2011 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TEN MILLION PESOS (P10,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to fund the construction of the Ormoc City Fire Station Building to be taken from out of the Unappropriated Surplus, End of Year 2010.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.


RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


ENACTED, DECEMBER 29, 2011

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to His Honor, the City Mayor Eric C. Codilla; the City Administrator; the City Treasurer; the City Budget Officer; the City Accountant; the City Auditor; the City Engineering Office thru: OIC-City Engineer Ranulfo D. Oliveros; and other offices concerned.

CARRIED by Nine (9) affirmative votes with Two (2) votes Against, registered by Hon. Claudio P. Larrazabal and Hon. Rolando M. Villasencio and One (1) Abstention registered by Hon. Mario M. Rodriguez.

WE HEREBY CERTIFY that the foregoing Appropriation Ordinance No. 2011-026 which approved the General Fund Supplemental Budget of Ormoc City for CY 2011 was duly enacted by the Twelfth Sangguniang Panlungsod ng Ormoc in its regular session.






