APPROPRIATION ORDINANCE NO. 2012-005 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE MILLION FIVE HUNDRED THOUSAND PESOS (P3,500,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2011, FOR THE CONSTRUCTION/UPGRADING OF PUBLIC BUILDING AND FACILITIES (REPAIR AND IMPROVEMENT OF SLAUGHTERHOUSE).

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. <u>2012 GENERAL FUND SUPPLEMENTAL BUDGET</u>. The sum of THREE MILLION FIVE HUNDRED THOUSAND PESOS (P 3,500,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the abovementioned project of the Ormoc City Slaughterhouse Division to be taken from the Unappropriated Surplus, End of Year 2011.

SECTION 2. <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval.

Department of Budget & Management, Manila, through the City Budget Officer, to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes
