APPROPRIATION ORDINANCE NO. 2012-007 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (P 400,000.00) TO SUPPLEMENT THE ACCOUNT – MOTOR VEHICLE- OF THE CITY AGRICULTURAL SERVICES OFFICE TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2011.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. <u>2012 GENERAL FUND SUPPLEMENTAL BUDGET</u>. The sum of FOUR HUNDRED THOUSAND PESOS (P 400,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the above-mentioned request of the City Agricultural Services Office to be taken from out of the Unappropriated Surplus, End of Year 2011.

SECTION 2. <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval.
