PREFATORY STATEMENT

PRESENTED to this august Body for consideration is an indorsement dated April 12, 2012 from the Office of the City Mayor relative to the request of Dr. Joseph C. Cortes, OIC-City Agricultural Services Office, for a Supplemental Appropriation in the amount of FOUR HUNDRED THOUSAND PESOS (P 400,000.00) to supplement the Motor Vehicle account for the purchase of brand new KIA Panoramic 4X4 (K2700) service vehicle for the City Agricultural Services Office;

The City Budget Officer issued a Certification dated April 11, 2012 stating therein that the sum of FOUR HUNDRED THOUSAND PESOS (P 400,000.00) is available from out of the Unappropriated Surplus, End of Year 2011, to supplement the account -Motor Vehicle- of the City Agricultural Services Office;

The City Treasurer, through a Certification dated April 11, 2012, certified that the sum of FOUR HUNDRED THOUSAND PESOS (P 400,000.00) is available from out of the Unappropriated Surplus, End of Year 2011 to Supplement the account "Motor Vehicle" of the same office;

FOREGOING PREMISES CONSIDERED, on motion of the City Councilor Jose C. Alfaro, Jr., Vice-Chairman, Committee on Appropriations and Finance, duly seconded by City Councilor Sotero M. Pepito; be it

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2012-007
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (P 400,000.00) TO SUPPLEMENT THE ACCOUNT – MOTOR VEHICLE- OF THE CITY AGRICULTURAL SERVICES OFFICE TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2011.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FOUR HUNDRED THOUSAND PESOS (P 400,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the above-mentioned request of the City Agricultural Services Office to be taken from out of the Unappropriated Surplus, End of Year 2011.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer, to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


ENACTED, May 17, 2012.

Codilla, the City Administrator, the City Treasurer, the City Budget Officer, the City Accountant, the City Auditor, the OIC-City Agricultural Services Office, Dr. Joseph C. Cortes and other offices concerned;


