## PREVATORY STATEMENT

## APPROPRIATION ORDINANCE NO. 2012-009 (GENERAL FUND)

AN ORDINANCE APPROPRIATING THE AMOUNT OF EIGHT HUNDRED TWENTY THOUSAND PESOS (P820,000.00) TO SUPPLEMENT THE APPROPRIATION - OPERATIONS AND MAINTAINANCE OF NEW ORMOC CITY HALL BUILDING-PARTICULARLY FOR THE FABRICATION OF ORMOC CITY HALL SIGNAGES TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2011.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. <u>2012 GENERAL FUND SUPPLEMENTAL BUDGET</u>. The sum of EIGHT HUNDRED TWENTY THOUSAND PESOS (P820,000,00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the appropriation for the Operations and Maintenance of New Ormoc City Hall Building particularly for the Fabrication of Ormoc City Hall Signages.

SECTION 2. <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval.
