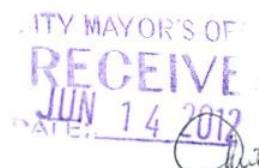

PREFATORY STATEMENT

PRESENTED to the Twelfth Sangguniang Panlungsod ng Ormoc for consideration is an Indorsement dated March 15, 2012 from the Office of the City Mayor relative to the request of Engr. Raulito D. Oliveros, OIC-City Engineer, for a Supplemental Appropriation in the amount of SEVEN MILLION SEVEN HUNDRED SIXTY THOUSAND PESOS (P 7,760,000.00) for the following projects, to wit:

1. Rehabilitation of Roads and Bridges Along Brgys. Lilo-An-R.M. Tan-Leondoni-Manlilinao	P 2,750,000.00
2. Rehabilitation of Roads and Bridges Along Brgys. Lilo-An-Labrador-Sabang Bao	P 1,990,000.00
3. Rehabilitation of Roads and Bridges along Brgys. Curva-San Vicente-Mas-in-Green Valley, Esperanza	P1,490,000.00
4. Rehabilitation of Roads and Bridges along Brgys. Valencia-Kadaohan-Maticaa-Guintigui-An	P1,530,000.00
TOTAL	P7,760,000.00

The City Budget Officer issued a Certification dated March 14, 2012 stating therein that funds are available from the Unappropriated Surplus, End of Year 2011, amounting to SEVEN MILLION SEVEN HUNDRED SIXTY THOUSAND PESOS (P 7,760,000.00) for the above-mentioned projects;

APPROPRIATION ORDINANCE NO. 2012-010
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF SEVEN MILLION SEVEN HUNDRED SIXTY THOUSAND PESOS (P7,760,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS END OF YEAR 2011 FOR THE FOLLOWING PROJECTS, TO WIT:

1. REHABILITATION OF ROADS AND BRIDGES ALONG BRGYS. LILO-AN-R.M. TAN-LEONDONI-MANLILINAO	- P2,750,000.00
2. REHABILITATION OF ROADS AND BRIDGES ALONG BRGYS. LILO-AN-LABRADOR-SABANG BAO	- P1,990,000.00
3. REHABILITATION OF ROADS AND BRIDGES ALONG BRGYS. CURVA-SAN VICENTE-MAS-IN-GREEN VALLEY, ESPERANZA	- P1,490,000.00
4. REHABILITATION OF ROADS AND BRIDGES ALONG BRGYS. VALENCIA KADAHIAN-MATICA-GUINTIGUI-AN	- P1,530,000.00

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of SEVEN MILLION SEVEN HUNDRED SIXTY THOUSAND PESOS (P 7,760,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to fund the above-mentioned projects of the City Engineers Office to be taken from Unappropriated Surplus, End of Year 2011.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer, to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, June 07, 2012.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to His Honor, the City Mayor Eric C. Codilla, the City Administrator, the OIC-City Engineer, Engr. Ranulfo D. Oliveros, the City Treasurer, the City Budget Officer, the City Accountant, the City Auditor, and other offices concerned;


