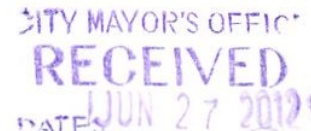

PRESENTED to this august Body for consideration is a communication dated April 17, 2012 from the City Mayor Eric C. Codilla, requesting for a Supplemental Appropriation in the amount of SIX MILLION PESOS (P 6,000,000.00), to supplement the following MOOE accounts under the Office of the City Mayor;

The City Budget Officer issued a Certification dated April 17, 2012 stating therein that funds amounting to SIX MILLION PESOS (P6,000,000.00) are available from the Unappropriated Surplus, End of Year 2011, to supplement the various Maintenance and Other Operating Expenses accounts under the Office of the City Mayor;

The City Treasurer, through a Certificate of Availability of Funds dated April 17, 2012 certified that funds are available from the Unappropriated Surplus, End of Year 2011 in the amount of SIX MILLION PESOS (P6,000,000.00) to supplement the various Maintenance and Other Operating Expenses accounts under the same office;

APPROPRIATION ORDINANCE NO. 2012-012
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF SIX MILLION PESOS (P6,000,000.00) TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2011 TO SUPPLEMENT THE VARIOUS MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) ACCOUNTS OF THE CITY MAYOR'S OFFICE, AS FOLLOWS:

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of SIX MILLION PESOS (P6,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the above-mentioned request of the City Mayor's Office to be taken from out of the Unappropriated Surplus, End of Year 2011.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.


RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer, to the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


ENACTED, June 21, 2012.


