APPROPRIATION ORDINANCE NO. 2012-013 (GENERAL FUND)

AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE MILLION PESOS (P3,000,000.00) TO SUPPLEMENT THE ACCOUNT – OTHER SERVICES – UNDER THE OFFICE OF THE CITY MAYOR FOR THE VARIOUS ACTIVITIES IN RELATION TO THE FORTHCOMING 2012 CHARTER DAY CELEBRATION OF THE CITY OF ORMOC TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2011.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:
