APPROPRIATION ORDINANCE NO. 2012-017 (General Fund)

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) TO BE TAKEN FROM OUT OF REVERSION OF THE CONTINUING APPROPRIATION- OTHER EQUIPMENT CY 2011 OF THE SANGGUNIANG PANLUNGSOD TO SUPPLEMENT THE CURRENT APPROPRIATION- IT EQUIPMENT AND SOFTWARE OUTLAY- OF SAME OFFICE.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. <u>2012 GENERAL FUND SUPPLEMENTAL BUDGET</u>. SECTION 2. <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval.
