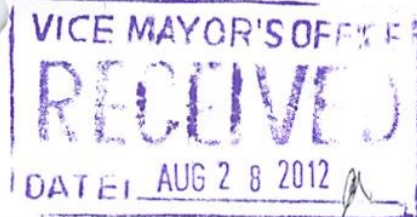
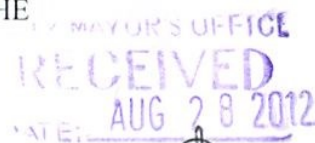

PREFATORY STATEMENT

PRESENTED to this august Body for consideration is an indorsement dated August 1, 2012 from the Office of the City Mayor relative to the request of the Honorable Vice Mayor Nepomuceno P. Aparis I for reversion of funds in the amount of TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) to be taken from the account - Other Equipment CY 2011- a Continuing Appropriation of the Sangguniang Panlungsod, to supplement the current appropriation -IT Equipment & Software Outlay- of the same office.

In connection thereto, the City Budget Officer through a Certification dated August 1, 2012 certified that funds amounting to Two Hundred Fifty Thousand Pesos (P250,000.00) from the Continuing Appropriation- Other Equipment CY 2011 of the Sangguniang Panlungsod may be made available for reversion to supplement the current appropriation of same office for IT Equipment & Software Outlay.

The City Treasurer, through a Certificate of Availability of Funds dated August 1, 2012 also certified that the amount of TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) are available from the Continuing Appropriation - Other Equipment CY 2011 of the Sangguniang Panlungsod and the same may be reverted and appropriated to supplement the current appropriation- IT Equipment & Software Outlay of same office.

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2012-017
(General Fund)

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) TO BE TAKEN FROM OUT OF REVERSION OF THE CONTINUING APPROPRIATION- OTHER EQUIPMENT CY 2011 OF THE SANGGUNIAN PANLUNGSOD TO SUPPLEMENT THE CURRENT APPROPRIATION- IT EQUIPMENT AND SOFTWARE OUTLAY- OF SAME OFFICE.

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated to supplement the current appropriation- IT Equipment & Software Outlay of the Sangguniang Panlungsod to be taken from out of the reversion of Continuing Appropriation - Other Equipment CY 2011 of same office.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.


RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;






