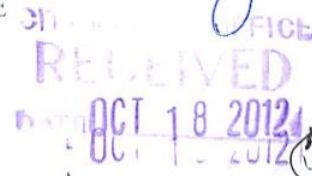

PRESENTED to this august Body for consideration is a communication dated September 12, 2012 from the Office of the City Mayor requesting for a Supplemental Appropriation in the amount of THREE MILLION PESOS (P 3,000,000.00) to supplement the various accounts of the same office as follows:

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of THREE MILLION PESOS (P3,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to fund the above-mentioned request of the City Mayor's Office, to be taken from Salary Savings of Vacant Positions covering the period January 1 to July 31, 2012.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.


