PREFATORY STATEMENT

PRESENTED to this august Body for consideration is a communication dated December 5, 2012 from the Honorable City Mayor Eric C. Codilla urgently requesting for a supplemental appropriation in the amount of THIRTY TWO MILLION FIVE HUNDRED NINETY TWO THOUSAND PESOS (P32,592,000.00) for the Productivity Enhancement Incentive (PEI) of the city officials and employees of the Local Government Unit of Ormoc City for CY 2012 as authorized under Budget Circular No. 2012-03. The benefit is set at P30,000.00 for each city official and employee subject to pro-rata as to the number of months in the service as provided in Sub-Item 5.2 of Budget Circular No.2012-03.

For the purpose of determining the total amount needed for the payment of said benefit, the Human Resource Management Officer submitted a listing showing that there are 1,089 qualified officials and employees who are entitled to receive the aforementioned benefit broken down as follows:

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2012-029 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF THRTY TWO MILLION FIVE HUNDRED NINETY TWO THOUSAND PESOS (P32,592,000.00) FOR THE PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) OF THE CITY OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY FOR CY 2012 AS AUTHORIZED UNDER BUNGET CIRCULAR NO. 2012-03 DATED NOVEMBER 29, 2012 AT THIRTY THOUSAND PESOS (P30,000.00) EACH TO BE TAKEN FROM OUT OF THE FOLLOWING SOURCES, TO WIT:

BE IT ENACTED, by the Twelfth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2012 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of THIRTY TWO MILLION FIVE HUNDRED NINETY TWO THOUSAND PESOS (P32,592,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the Productivity Enhancement Incentive (PEI) of the city officials and employees of the Local Government Unit of Ormoc City for CY 2012 to be taken from out of the Unappropriated Surplus, End of Year 2011 and Personal Services Savings.

SECTION 2. <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, December 13, 2012.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to His Honor, the City Mayor Eric C. Codilla; the City Administrator; the City Treasurer; the City Budget Officer; the City Accountant; the City Auditor; the Human Resource Management Office, and others concerned – all in Ormoc City;
