PREFATORY STATEMENT

WHEREAS, presented to the Thirteenth Sangguniang Panlungsod ng Ormoc for consideration is an urgent Indorsement dated October 3, 2014 from the Honorable City Mayor, Edward C. Codilla, relative to the request of Engr. Domardoni C. Cayanong, City General Services Officer, for Supplemental Budget in the amount of TWENTY FIVE MILLION TWO HUNDRED FOUR THOUSAND NINE HUNDRED FIVE PESOS (P25,204,905.00), chargeable against 2013 Unappropriated Surplus and intended for the streetlightings of various barangays and in the City Proper:

WHEREAS, the installation of streetlights to several barangays as well as in the City Proper is deemed imperative considering the extreme damage to the said facilities caused by super typhoon Yolanda. Hence, the immediate repair and installation of streetlights around Ormoc City needs to be undertaken in the interest of public order and safety, and for the recovery and development of the Yolandaaffected communities in the City;

WHEREAS, the City Budget Officer issued a Certification dated September 29, 2014, with the information that the amount of TWENTY FIVE MILLION TWO HUNDRED FOUR THOUSAND NINE HUNDRED FIVE PESOS (P25,204,905.00), intended for Streetlightings of various barangays – may be taken from the Unappropriated Surplus of 2013;

WHEREAS, the City Treasurer, through a Certificate of Availability of Funds dated October 2, 2014, certified that the amount above requested is available from the Unappropriated Surplus, end of year 2013, which may be used as a source of funds for Streetlightings as requested by Engr. Domardoni C. Cayanong, City General Services Officer;

APPROPRIATION ORDINANCE NO. 2014-009 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY FIVE MILLION TWO HUNDRED FOUR THOUSAND NINE HUNDRED FIVE PESOS (P25,204,905.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2013 FOR THE INSTALLATION OF STREETLIGHTINGS OF VARIOUS BARANGAYS AND IN CITY PROPER.

BE IT ENACTED, by the Thirteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. <u>2014 GENERAL FUND SUPPLEMENTAL BUDGET</u>. The sum of TWENTY FIVE MILLION TWO HUNDRED FOUR THOUSAND NINE HUNDRED FIVE PESOS (P25,204,905.00), of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the installation of Streetlightings of various barangays and in the City Proper, to be taken from the Unappropriated Surplus, End of Year 2013.

SECTION 2. <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents thereof, be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
