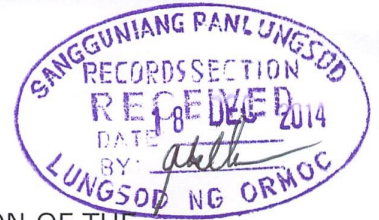

PREFATORY STATEMENT

PRESENTED to the Thirteenth Sangguniang Panlungsod ng Ormoc for consideration is an Indorsement dated November 14, 2014 from the Office of the City Mayor relative to the request of Engr. Ranulfo D. Oliveros, City Engineer, for supplemental budget thru reversion of Current Year appropriation in the amount of NINE HUNDRED NINETY ONE THOUSAND NINE HUNDRED PESOS (P991,900.00) as follows;

Other Equipment	P991,900.00 - Office Equipment P991,900.00

The above-requested supplemental budget is purposely intended for the supply and installation of airconditioning units which are deemed important considering the enormous damage caused by super Typhoon Yolanda to the City Engineering Office. Hence, the immediate procurement of the same be undertaken for the recovery and development of said office;

The City Budget Officer issued a Certification dated November 13, 2014 stating therein that the amount of NINE HUNDRED NINETY ONE THOUSAND NINE HUNDRED PESOS (P991,900.00), intended for the supply and installation of airconditioning units of said office is available to be taken from out of the reversion of Current Year appropriation by way of a Supplemental Budget, to wit:

The City Treasurer, through a Certificate of Availability of Funds dated November 14, 2014 certified that the above requested amount is available under the Other Equipment account of City Engineer's Office, which may be used as a source of funds for the reversion of Appropriation for Office Equipment of same office;

RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2014-013
(General Fund)

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF NINE HUNDRED NINETY ONE THOUSAND NINE HUNDRED PESOS (P991,900.00) TO BE TAKEN FROM OUT OF THE REVERSION OF CURRENT YEAR APPROPRIATION FOR OFFICE EQUIPMENT OF THE CITY ENGINEER'S OFFICE TO SUPPLEMENT THE APPROPRIATION FOR OFFICE EQUIPMENT OF SAME OFFICE PARTICULARLY FOR THE SUPPLY AND INSTALLATION OF AIRCONDITIONING UNITS.

BE IT ENACTED, by the Thirteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2014 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of NINE HUNDRED NINETY ONE THOUSAND NINE HUNDRED PESOS (P991,900.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated to supplement the appropriation for Office Equipment of the City Engineer's Office particularly for the supply and installation of airconditioning units to be taken from out of the reversion of Current Year Appropriation - Other Equipment- of same office.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


ENACTED, December 09, 2014.


