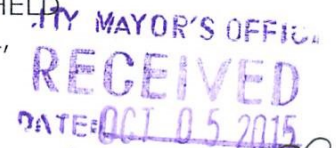

PREFATORY STATEMENT

WHEREAS, presented to this Thirteenth Sanggunian for consideration is an Indorsement dated September 14, 2015 from the Office of the City Mayor regarding the request of Engr. Ranulfo D. Oliveros, City Engineer, for a supplemental budget in the amount of THREE MILLION TWO HUNDRED THOUSAND PESOS ONLY (P3,200,000.00) to be taken from the Unappropriated Surplus, end of year 2014 for the purchase of motor vehicles for the City Engineer's Office;

WHEREAS, the requested supplemental budget is deemed essential to carry out the intention of the City Engineer's Office to acquire additional motor vehicles for the improvement of its day to day operation and for convenience in monitoring the implementation of various projects undertaken by said office;

WHEREAS, the City Budget Officer issued a Certification dated September 11, 2015, stating that the amount of THREE MILLION TWO HUNDRED THOUSAND PESOS (P3,200,000.00), is available to be taken from the Unappropriated Surplus, end of year 2014 which fund may be utilized for the purchase of Two (2) Units 4 x 4 Brand New motor vehicles for the City Engineer's Office;

WHEREAS, the City Treasurer, through a Certificate of Availability of Funds dated September 11, 2015 certified that funds are available from the Unappropriated Surplus end of year 2014, and the same may be used as a funding source to purchase the motor vehicles as requested by the aforementioned office;

FOREGOING PREMISES CONSIDERED, on motion of Honorable SP Member, Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation, severally seconded by Honorable SP Members Tomas R. Serafica, Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, to enact:

*APPROPRIATION ORDINANCE NO. 2015-012  
(General Fund)*

*AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE MILLION TWO HUNDRED THOUSAND PESOS (P3,200,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2014 FOR THE PURCHASE OF TWO UNITS (2) 4 X 4 BRAND NEW MOTOR VEHICLES FOR THE CITY ENGINEER'S OFFICE.*

BE IT ENACTED, by the Thirteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2015 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of THREE MILLION TWO HUNDRED THOUSAND PESOS (P3,200,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the purchase of motor vehicles for the City Engineer's Office to be taken from the Unappropriated Surplus, end of year 2014.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes.

ENACTED, October 01, 2015.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance one each to His Honor, the City Mayor Edward C. Codilla; the City Administrator; the City Legal Officer; the City Engineer's Office; the City Treasurer, the City Budget Officer, the City Accountant, the City Auditor, the City Director-DILG, Ms. Lucia C. Ong and other offices concerned;
