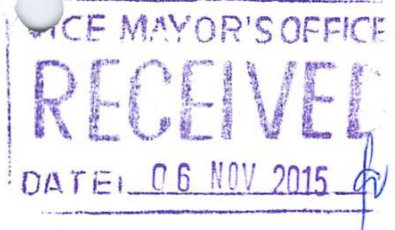
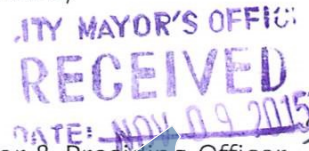

PREFATORY STATEMENT

WHEREAS, PRESENTED to the Thirteenth Sangguniang Panlungsod ng Ormoc for consideration is an urgent Indorsement from the Honorable City Mayor Edward C. Codilla dated October 27, 2015 requesting for a supplemental appropriation in the amount of FIVE MILLION NINE HUNDRED THIRTY FOUR THOUSAND PESOS (P5,934,000.00) for the implementation of Senior Citizens Welfare Program specifically for the payment of Birthday Gift to qualified Senior Citizens covering the months of October, 2015 to December, 2015 including the late filers for the months of August and September, 2015;

WHEREAS, the Head of the Office of the Senior Citizens Affairs, Mrs. Mansueta N. Teleron, submitted the List of Senior Citizens who are recipients of the Birthday Gift on the aforementioned months indicating therein a total of 3,956 Senior Citizens at ONE THOUSAND FIVE HUNDRED PESOS (P1,500.00) each for a total funding requirement of FIVE MILLION NINE HUNDRED THIRTY FOUR THOUSAND PESOS (P5,934,000.00);

WHEREAS, to recall, the grant of Birthday Gift to Senior Citizens is anchored on the provisions of Ordinance No. 184 duly enacted on June 20, 2013 hence, a yearly appropriation is set aside in the city's Annual Budget for the implementation of the said program under the account - Donations - of the Office of Senior Citizens Affairs (OSCA);

WHEREAS, for CY 2015 a total of ELEVEN MILLION PESOS (P11,000,000.00) has been appropriated for the said program however, due to variations in the number of Senior Citizens who are qualified to receive such benefit the appropriated amount was already depleted thus, the need to pass a supplemental appropriation covering the matter;

WHEREAS, the City Budget Officer issued a Certification dated October 26, 2015 certifying therein that the amount above requested totaling to FIVE MILLION NINE HUNDRED THIRTY FOUR THOUSAND PESOS (P5,934,000.00) is available for the payment of Senior Citizens Birthday Gift under the account- Donations – of the Office of the Senior Citizens Affairs- which may be taken from the Unappropriated Surplus , end of Year 2014;

WHEREAS, the ICO-City Treasurer through a Certificate of Availability of Funds dated October 27, 2015 likewise certified that funds are available which may be taken from the Unappropriated Surplus, end of Year 2014 for the payment of Birthday Gift of Senior Citizens under the account-Donations - of the Office of the Senior Citizens Affairs;

FOREGOING PREMISES CONSIDERED, on joint motion presented by the Honorable SP Member Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation and the Honorable SP Member Vincent L. Rana, Chairman, Committee on Social Welfare, Senior Citizens, Women & Family, severally seconded by the Honorable SP Members Rolando M. Villasencio, Tomas P. Serafica, Ruben R. Capahi, Benjamin S. Pongos, Jr., Antonio M. Codilla, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, to enact:

*APPROPRIATION ORDINANCE NO. 2015-017
(General Fund)*

AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE MILLION NINE HUNDRED THIRTY FOUR THOUSAND PESOS (P5,934,000.00) TO SUPPLEMENT THE ACCOUNT - DONATIONS – OF THE OFFICE OF THE SENIOR CITIZENS AFFAIRS (OSCA) FOR THE PAYMENT OF SENIOR CITIZENS' BIRTHDAY GIFT FOR THE MONTHS OF AUGUST, 2015 TO DECEMBER, 2015 TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2014.

BE IT ENACTED, by the Thirteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2015 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FIVE MILLION NINE HUNDRED THIRTY FOUR THOUSAND PESOS (P5,934,000.00)) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to supplement the account – Donations – of the Office of the Senior Citizens Affairs for the payment of Birthday Gift of Senior Citizens for the months of August, 2015 to December, 2015 to be taken from the Unappropriated Surplus, end of year 2014.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
