PREFATORY STATEMENT

WHEREAS, presented to this august Body for consideration is an Indorsement dated September 2, 2016 from the City Mayor Richard I. Gomez, in relation to the request of Engr. Raoul E. Cam, City Planning and Development Coordinator, for a Supplemental Budget in the amount of SEVENTEEN MILLION, FOUR HUNDRED THIRTY SIX THOUSAND SIXTY TWO PHILIPPINE PESOS AND FIFTY CENTAVOS (PHP17,436,062.50), as LGU counterpart to the Bottom-up Budgeting (BuB) for the projects included in the FY 2016 Local Poverty Reduction Action Plan (LPRAP);

WHEREAS, the requested supplemental budget is LGU-Ormoc's cash counterpart for the implementation of the BuB Projects in Ormoc City as identified by the Local Poverty Reduction Action Team (LPRAT) for FY 2016, which was approved by this Sanggunian through SP Resolution No. 2014-231;

WHEREAS, through a Certification of Availability of Funds dated September 1, 2016, the City Budget Officer, the City Treasurer and the City Accountant, certified that the amount of SEVENTEEN MILLION, FOUR HUNDRED THIRTY SIX THOUSAND SIXTY TWO PHILIPPINE PESOS AND FIFTY CENTAVOS (PHP17,436,062.50), to cover the requested LGU Counterpart for the 2016 Bottom-up Budgeting projects as approved per SP Resolution No. 2014-231, is available to be taken from the Unappropriated Surplus, end of year 2015, and may be used to cover the said request;

WHEREAS, this Sanggunian finds that the requested supplemental budget is not contrary to the law or public policy, and that the projects to be funded therefrom is extremely beneficial to the interests of the City, and so therefore, most deserving of its utmost support and favorable consideration;

*APPROPRIATION ORDINANCE NO. 2016-004  
(General Fund)*

*AN ORDINANCE APPROPRIATING THE AMOUNT OF SEVENTEEN MILLION, FOUR HUNDRED THIRTY SIX THOUSAND SIXTY TWO PHILIPPINE PESOS AND FIFTY CENTAVOS (PHP17,436,062.50), TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2015 AS LOCAL GOVERNMENT UNIT (LGU) COUNTERPART TO THE BOTTOM-UP BUDGETING (BUB) FOR THE PROJECTS INCLUDED IN THE FY 2016 LOCAL POVERTY REDUCTION ACTION PLAN (LPRAP).*

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2016 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of SEVENTEEN MILLION, FOUR HUNDRED THIRTY SIX THOUSAND SIXTY TWO PHILIPPINE PESOS AND FIFTY CENTAVOS (PHP17,436,062.50), of the General Fund Supplemental Budget of Ormoc City is hereby appropriated as LGUs counterpart for the BuB Projects included in the FY 2016 LPRAP, to be taken from the Unappropriated Surplus, End of Year 2015.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents thereof, be submitted to the Secretary, Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget and Management, Tacloban City, for review purposes;


