PREFATORY STATEMENT

WHEREAS, presented to this Sanggunian for consideration is an urgent Indorsement dated September 21, 2016 from the Office of the City Mayor, pertaining to the request of Engr. Domardoni C. Cayanong, City General Services Officer, for a supplemental appropriation to purchase Construction and Heavy Equipment particularly one (1) unit of Brand New Landfill Bulldozer, Track Type Tractor in the amount of TWENTY MILLION (P20,000,000.00)PESOS;

WHEREAS, the procurement of the said heavy equipment is necessary and deemed very important for the effective maintenance and sanitation of Landfill area for a healthier and cleaner living environment in Ormoc City;

Whereas, through a certification dated September 20, 2016, the City Budget Officer, the City Treasurer, and the City Accountant, certified that the amount of TWENTY MILLION PESOS (P20,000,000.00) is deemed available, to be taken from the Unappropriated Surplus, end of year 2015 of the General fund, and the same may be used for the purchase of one (1) unit brand New landfill Bulldozer under the account – Construction and Heavy Equipment of the General Services Office;

APPROPRIATION ORDINANCE NO. 2016-005 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY MILLION PESOS (P20,000,000.00) FOR THE PURCHASE OF ONE (1) UNIT BRAND NEW LANDFILL BULDOZER UNDER THE ACCOUNT - CONSTRUCTION AND HEAVY EQUIPMENT OF THE GENERAL SERVICES OFFICE, TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2015 OF THE GENERAL FUND.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2016 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TWENTY MILLION PESOS (P20,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the purchase of one (1) unit brand New landfill Bulldozer under the account – Construction and heavy Equipment of the General Services Office, to be taken the Unappropriated Surplus, end of year 2015.

SECTION 2. <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

Bagares; the General Services Officer and other offices concerned;
