BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2016 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FOUR MILLION TWO HUNDRED FORTY SEVEN THOUSAND FOUR HUNDRED FORTY FIVE PESOS & 04/100 (P4,247,445.04), of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for the purchase of materials for streetlightings for various barangays in Ormoc City to be taken from out of the reversion of the excess funds of the post Yolanda completed streetlighting projects in various barangays.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


