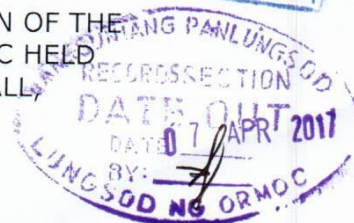

PREFATORY STATEMENT

WHEREAS, the Office of the City Mayor forwarded an Indorsement dated March 13, 2017 to this august Body for consideration, an urgent request for a supplemental Budget in the total amount of FIVE MILLION TWO HUNDRED THOUSAND PESOS (P5,200,000.00) for the purchase of new Audio System for Ormoc City Superdome;

WHEREAS, the requested supplemental appropriation covering the matter is deemed imperative to carry out the proposed Audio System purchase which is in line with the City Mayor's goal to rehabilitate and improve the existing LGU facilities and equipment for the betterment of public service;

WHEREAS, the present audio system of Ormoc City Superdome was acquired way back 1996 and had undergone upgrading sometime in 2009 and 2014. Due to wear and tear, its sound quality had deteriorated, thus the need for the acquisition of a new audio system that will produce audible, pleasant and full sound for the satisfaction of the general public considering that the Ormoc City Superdome is a constant venue of important events and competitions in the City;

WHEREAS, through a certification dated March 22, 2017 the City Budget Officer and the City Treasurer certified that the amount of FIVE MILLION TWO HUNDRED THOUSAND PESOS (P5,200,000.00) for the purchase of Audio System for the Ormoc City Superdome under the account - Other Property, Plant and Equipment is deemed available to be taken from the Unappropriated Surplus, end of year 2016;

RESOLVED, to enact:

**APPROPRIATION ORDINANCE NO. 2017-005
(General Fund)**

AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE MILLION TWO HUNDRED THOUSAND PESOS (P5,200,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2016, FOR THE PURCHASE OF NEW AUDIO SYSTEM FOR THE ORMOC CITY SUPERDOME UNDER THE ACCOUNT - OTHER PROPERTY, PLANT AND EQUIPMENT.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc in regular session assembled, That:

SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FIVE MILLION TWO HUNDRED THOUSAND PESOS (P5,200,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the purchase of new Audio System for the Ormoc City Superdome to be taken from the Unappropriated Surplus, end of year 2016.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;




