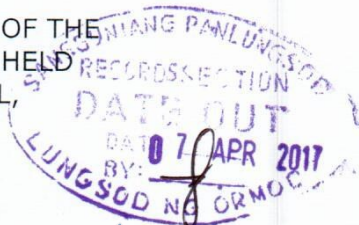

PREFATORY STATEMENT

WHEREAS, forwarded to this august Body for consideration, is an urgent Indorsement dated March 24, 2017, from the Office of the City Mayor, pertaining to the request of Engr. Rodolfo H. Labarda, Jr., OIC-Market Administrator for a supplemental budget in the total amount of EIGHT MILLION NINE HUNDRED EIGHTY-EIGHT THOUSAND PESOS (P8,988,000.00);

WHEREAS, as laid in the letter of Engr. Labarda, the requested appropriation will be used to fund the following programs/project, to wit;

1.) Water Treatment Facility (Construction of Wastewater Barrier)	- P 188,000.00
2.) Maintenance and other Operating Expenses (MOOE): Repair and Maintenance: Construction and Heavy Equipment	- 600,000.00
3.) Wages of Job Orders(CY 2017)	- 8,200,000.00
TOTAL	- <u>P8,988,000.00</u>

WHEREAS, the funding requirement of the subject programs/project is necessary and has to be provided in line with the City's intention to maintain cleanliness and sanitation in the Public Market and also to ensure that there is ready funds for the repairs and maintenance of garbage compactors assigned to the Market premises;

WHEREAS, further, due to the increasing number of Job Orders under the Public Market Office whose services are indispensable to the smooth operation and efficient administration of the Public Market, the supplemental budget to cover their wages for CY 2017 is deemed imperative;

WHEREAS, the City Budget Officer, the City Treasurer, and the City Accountant, through a certification dated March 8, 2017, certified that the amount of EIGHT MILLION NINE HUNDRED EIGHTY-EIGHT THOUSAND PESOS (P8,988,000.00) is deemed available for appropriation to be taken from the Unappropriated Surplus, end of year 2016, to fund the following object of expenditures under the Public Market Office, to wit;

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc in regular session assembled, That:

SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of EIGHT MILLION NINE HUNDRED EIGHTY-EIGHT THOUSAND PESOS (P8,988,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated to fund the abovestated object of expenditures of the Public Market Office, to be taken from the Unappropriated Surplus, end of year 2016.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
