PREFATORY STATEMENT

WHEREAS, for consideration by this Fourteenth Sangguniang Panlungsod ng Ormoc is an urgent Indorsement dated April 7, 2017 from the Office of the City Mayor requesting for a supplemental appropriation in the total amount of TEN MILLION PESOS (P10,000,000.00) for the purchase of Two (2) units Garbage Dumptrucks for the General Services Office (GSO) use;

WHEREAS, the supplemental budget request was made in view of the pressing need for additional Garbage Trucks to intensify the garbage collection and disposal services in the city;

WHEREAS, as manifested by the City General Services Officer, the current number of Garbage Truck units of GSO are not enough to service the daily volume of garbage due for collection in various barangays within the city, hence, the necessity to acquire additional garbage trucks to address the problem ;

WHEREAS, the matter was referred to the Offices of the City Budget Officer, City Accountant, and City Treasurer for appropriate recommendations as to the funding source thereof; and in this respect a Certification dated April 5, 2017 was issued by the concerned offices certifying therein that the amount of TEN MILLION PESOS (P10,000,000.00) for the purchase of Two (2) Units Garbage Dumptrucks under the account Construction & Heavy Equipment of the GSO is available to be taken from the Unappropriated Surplus, end of Year 2016;

WHEREAS, the request is deemed meritorious as its aim is for the improvement of public service for the good and benefit of the Ormocanon communities;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP member Mario M. Rodriguez, Chairman, Committee on Finance & Appropriation, severally seconded by SP Members Rolando M. Villasencio, Nolito M. Quilang, Lea Doris C. Villar and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to enact:

**APPROPRIATION ORDINANCE NO. 2017-010
(General Fund)**

**AN ORDINANCE APPROPRIATING THE AMOUNT OF
TEN MILLION PESOS (P10,000,000.00) TO BE
TAKEN FROM THE UNAPPROPRIATED SURPLUS, END
OF YEAR 2016 FOR THE PURCHASE OF TWO(2)
UNITS BRAND NEW GARBAGE DUMPTRUCKS UNDER
THE ACCOUNT CONSTRUCTION AND HEAVY
EQUIPMENT OF THE GENERAL SERVICES OFFICE.**

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc in Regular Session assembled, That:

SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TEN MILLION PESOS (P10,000,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the purchase of Two (2) units Garbage Dumptrucks for the General Services Office use to be taken from the Unappropriated Surplus, end of Year 2016.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, May 04, 2017.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to the City Mayor Richard I. Gomez; the City Administrator, Mr. Vincent L. Emnas; the Acting City Legal Officer, Atty. Marcelo C. Oñate; the City Budget Officer; the City Accountant; the City Treasurer; the City Auditor; the City General Services Office; the OIC-City Director, DILG, Engr. Jesus Jeremy D. Bagares; and other offices concerned;
