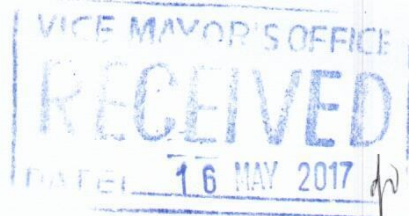

PREFATORY STATEMENT

WHEREAS, presented to the Fourteenth Sangguniang Panlungsod ng Ormoc for consideration is a communication dated April 20, 2017 from the Office of the City Mayor urgently requesting for a supplemental appropriation amounting to FOUR MILLION THREE HUNDRED TWENTY-TWO THOUSAND PESOS (P4, 322,000.00) for the purchase of two (2) units of tractors with four (4) farm implements: disc plow, disc harrow, rotavator and ridger;

WHEREAS, through a certification issued on April 19, 2017 by Ms. Sabrina P. Duero, City Budget Officer, Ms. Delia C. Vilbar, City Treasurer and Ms. Rosario G. Serafica, OIC-City Accountant, the said amount requested for the proposed purchase of tractors with farm implements under the account -Agricultural and Forestry Equipment of the City Agriculture's Office is available to be taken from the Unappropriated Surplus, end of year 2016;

WHEREAS, it is the declared policy of the State to give the highest priority to the development of agriculture such that equitable distribution of benefits and opportunities is realized through the empowerment of small farmers;

WHEREAS, some of the small farmers in Ormoc City need the support of the Local Government Unit in their farming activities such as land preparation and that the LGU recognizes the fact that the welfare and development of the small farmers is a primordial responsibility;

WHEREAS, tractor use on the farm, when properly applied, can improve overall efficiency, maximize both land and labor productivity and lead to increase economic returns for the farmer;

WHEREAS, the purchase of said tractor units aims to render greater service to the small farmers of the City in the whole stretch of their production function with the intention of attaining greater farm productivity by reducing labor cost and time spent in the land thru farm mechanization;

AN ORDINANCE APPROPRIATING THE AMOUNT OF FOUR MILLION THREE HUNDRED TWENTY-TWO THOUSAND PESOS (P4,322,000.00) FOR THE PURCHASE OF TWO (2) UNITS OF BRAND NEW TRACTORS WITH FOUR (4) FARM IMPLEMENTS: DISC PLOW, DISC HARROW, ROTAVATOR AND RIDGER UNDER THE ACCOUNT- AGRICULTURAL AND FORESTRY EQUIPMENT OF THE CITY AGRICULTURE OFFICE TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2016.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc,
That:

SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FOUR MILLION THREE HUNDRED TWENTY-TWO THOUSAND PESOS (P4,322,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the purchase of TWO (2) UNITS OF BRAND NEW TRACTORS WITH FOUR (4) FARM IMPLEMENTS: DISC PLOW, DISC HARROW, ROTAVATOR AND RIDGER under the account - Agricultural and Forestry Equipment of the City Agriculture's Office to be taken from the Unappropriated Surplus, End of Year 2016.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


ENACTED, May 11, 2017.
