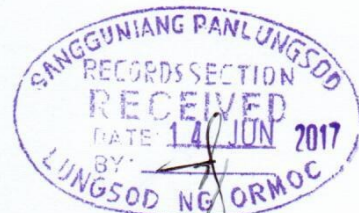

PREFATORY STATEMENT

WHEREAS, the Office of the City Mayor forwarded an Endorsement dated May 26, 2017 to this august Body for consideration, requesting for a supplemental appropriation in the amount of FIVE HUNDRED SIXTY THREE THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS (PHP563,878.00), for the Construction of Child Friendly Learning Center of Barangay Cagbuhangin, Ormoc City;

WHEREAS, the Sangguniang Barangay of Cagbuhangin has passed and approved Resolution No. 06 Series of 2017, requesting the Ormoc City Mayor Richard I. Gomez to allocate the above-requested funds for the aforesaid purpose;

WHEREAS, Section 2 of Republic Act No. 7743 provides the legal basis of public policy in promoting the moral and intellectual well-being of the people, elevate the literacy level of every Filipino and recognize the vital role of knowledge and information in nation-building by establishing public libraries and reading centers in every barangay throughout the Philippines;

WHEREAS, SHERYL LYNN FOUNDATION donated the amount of ONE HUNDRED THIRTY THOUSAND PESOS (PHP130,000.00) for the proposed Child Friendly Learning Center, which has a total project cost of SIX HUNDRED NINETY THREE THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS & 36/100 (PHP693,878.36);

WHEREAS, the Sangguniang Barangay of Cagbuhangin is financially incapable of providing the remaining funds required to implement the proposed project thus, sought the assistance of LGU-Ormoc through the City Mayor Richard I. Gomez for possible funding support to carry out the said project;

WHEREAS, the requested funds is indispensable for the realization of the Learning Center project which is deemed to be of great help to the out of school youth to eliminate child labor and to serve as a multi-functional venue for children's activities in support to the strong campaign on the Barangay Council for the Protection of Children (BCPC);

WHEREAS, through a certification dated March 22, 2017 the City Budget Officer, the City Treasurer, and the OIC-City Account, stated that the amount of FIVE HUNDRED SIXTY THREE THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS (PHP563,878.00) which may be taken from the 2015 Continuing Appropriation – Const./Rep./Improv't. of covered court at Brgy. Bantigue is deemed available for reversion for the Construction of Community Learning Center at Brgy. Cagbuhangin, Ormoc City with AIP Reference Code 8000-9-24;

FOREGOING PREMISES CONSIDERED, on motion of SP Member Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Nolito M. Quilang, Gregorio G. Yrastorza III, Mariano Y. Corro, Tomas R. Serafica and Rolando M. Villasencio; be it

RESOLVED, to enact:

**APPROPRIATION ORDINANCE NO. 2017-013
(General Fund)**

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF FIVE HUNDRED SIXTY THREE THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS (PHP563,878.00) TO BE TAKEN FROM OUT OF THE REVERSION OF 2015 CONTINUING APPROPRIATION – CONST./REP./IMPROV'T. OF COVERED COURT AT BARANGAY BANTIGUE TO CONSTRUCTION OF COMMUNITY LEARNING CENTER AT BARANGAY CAGBUHANGIN, ORMOC CITY WITH AIP REFERENCE CODE 8000-9-24.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FIVE HUNDRED SIXTY THREE THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS (PHP563,878.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for Construction of Community Learning Center at Brgy. Cagbuhangin, Ormoc City with AIP Reference Code 8000-9-24 to be taken from the 2015 Continuing Appropriation – Const./Rep./Improv't. of the covered court at Brgy. Bantigue, Ormoc City.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
