PREFATORY STATEMENT

WHEREAS, the Office of the City Mayor issued an Endorsement dated August 24, 2017 to this august Body for consideration, relative to the request of Archilles A. Silva, City Civil Registrar, for reversion of funds particularly from the 2016 Continuing Appropriation account - Other Property, Plant & Equipment of the Office of the City Civil Registrar in the total amount of TWO HUNDRED TEN THOUSAND PESOS (P210,000.00), to be reverted to the account - Furnitures & Fixtures of same office for the purchase of Roller Blinds;

WHEREAS, the Office of the City Civil Registrar needs to purchase Roller Blinds considering that its location is direct to the sunlight. The installation of Roller Blinds is the best way to curtail the incoming sunlight that gives distraction to the employees in the performance of their day to day functions;

WHEREAS, the proposed fund reversion is necessary to carry out the aforementioned purpose of the Office of the City Civil Registrar, which request is of great help for the improvement of the day to day operation of the said office in order to achieve its goals for effective and efficient public service;

WHEREAS, through a certification dated August 22, 2017 the City Budget Officer, the City Treasurer, and the OIC-City Accountant, stated that the amount of TWO HUNDRED TEN THOUSAND PESOS (P210,000.00) for the purchase of Roller Blinds under the account - Furnitures and Fixtures - is deemed available to be sourced from the reversion of the 2016 Continuing Appropriation of the Office of the City Civil Registrar, to wit:

RESOLVED, to enact:

**APPROPRIATION ORDINANCE NO. 2017-021
(General Fund)**

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF TWO HUNDRED TEN THOUSAND PESOS (P210,000.00) TO BE TAKEN FROM OUT OF THE REVERSION OF CY 2016 CONTINUING APPROPRIATION ACCOUNT – OTHER PROPERTY, PLANT AND EQUIPMENT OF THE CITY CIVIL REGISTRAR TO SUPPLEMENT THE ACCOUNT – FURNITURES AND FIXTURES OF SAME OFFICE FOR THE PURCHASE OF ROLLER BLINDS.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc,
That:

SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of TWO HUNDRED TEN THOUSAND PESOS (P210,000.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for the purchase of Roller Blinds under the account Furnitures and Fixtures of the City Civil Registrar's Office to be taken from the 2016 Continuing Appropriation account – Other Property, Plant & Equipment of same office.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;


ENACTED, September 14, 2017.

Bagares and other offices concerned;


