PREFATORY STATEMENT

WHEREAS, presented to this Sanggunian for consideration is an Indorsement dated October 2, 2017 from the Office of the City Mayor, pertaining to the request of Rolando Ihay R. Gaspar Jr., City Youth Development Officer, for a supplemental appropriation in the total amount of FIVE HUNDRED SEVENTY FIVE THOUSAND PESOS (P575,000.00) for the programs and operational expenses of the City Youth Development Office (CYDO) for the remaining months of Calendar Year 2017;

WHEREAS, the City Youth Development Office is a newly created office under the Office of the City Mayor through Ordinance No. 15 dated December 29, 2016 of this Sanggunian. Section 27 of Ordinance No. 15 provides that the appropriation necessary to cover the cost of operations of CYDO for CY 2017 shall be taken from the Unappropriated Surplus, End of Year 2016 hence, the appropriation request is deemed proper in order for the said office to normally function and perform its mandated tasks and responsibilities;

WHEREAS, it is essential that proper fund allocation shall be made to procure necessary office equipment and supplies for CYDO considering that it is a new office as well as for its starting programs and activities, to achieve and ensure the efficient fulfillment of its core mandate;

WHEREAS the Offices of the City Budget Officer, City Treasurer, and OIC-City Accountant issued a certification dated July 28, 2017, certifying therein that the amount of FIVE HUNDRED SEVENTY FIVE THOUSAND PESOS (P575,000.00), is deemed available to be taken from the Unappropriated Surplus, end of year 2016, to fund the Current Operating Expenditures and Capital Outlay of the City Youth Development Office/City Mayor's Office, to wit;

RESOLVED, to enact:

**APPROPRIATION ORDINANCE NO. 2017-024**  
**(General Fund)**

**AN ORDINANCE APPROPRIATING THE AMOUNT OF FIVE HUNDRED SEVENTY FIVE THOUSAND PESOS (P575,000.00), TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2016 TO FUND THE CURRENT OPERATING EXPENDITURES AND CAPITAL OUTLAY OF THE CITY YOUTH DEVELOPMENT OFFICE (CYDO)/CITY MAYOR'S OFFICE.**

**SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET.** The sum of FIVE HUNDRED SEVENTY FIVE THOUSAND PESOS (P575,000.00), of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the Current Operating Expenditures and Capital Outlay of the City Youth Development Office to be taken from the Unappropriated Surplus, end of year 2016.

**SECTION 2. EFFECTIVITY.** This Appropriation Ordinance shall take effect immediately upon its approval subject however, to the compliance of the posting and publication requirements as provided in the Local Government Code of 1991.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance together with all supporting documents be submitted to the Honorable Secretary, Department of Budget & Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
