WHEREAS, presented to the 14th Sangguniang Panlungsod ng Ormoc for consideration is an Endorsement dated October 25, 2017 from the City Mayor Richard I. Gomez requesting for a supplemental appropriation in the amount of Eight Hundred Thousand Pesos (P800,000.00) chargeable against the Unappropriated Surplus, End of Year 2016 for the account- Travelling Expense – Foreign (5-02-01-020) of the Office of the City Mayor;

WHEREAS, the supplemental appropriation request was made in connection with the official foreign travel of the City Mayor to the U.S.A. to participate in the conference and workshop on "Deepening Understanding on the Governance Trends and Challenges of Federalism": Best Practice Learning for Change- An International Benchmarking Program scheduled on November 5-6, 2017;

WHEREAS, the seminar and workshop was organized by Creative Learning, a non- profit organization based in Washington D.C. involved in assisting communities, non-governmental organizations and educational institutions to foster change that has lasting social impact and enhances the capacity of local organization around the world to improve the lives of the people, jointly with the Local Government Academy (LGA)-Philippines, an attached agency of the Department of the Interior and Local Government (DILG) which is a leading provider of capacity building services to LGUs;

WHEREAS, for purposes of determining the appropriate source and availability of funds to cover the said request of the City Mayor, the matter was referred to the Offices of the City Budget Officer, City Treasurer and City Accountant from which a Certification dated October 25, 2017 was issued stating therein that the amount of Eight Hundred Thousand Pesos (P800,000.00) is deemed available to be sourced from the Unappropriated Surplus, End of Year 2016 to fund the account Travelling Expense - Foreign (5-02-01-020) of the Office of the City Mayor;

APPROPRIATION ORDINANCE NO. 2017-026 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (P800,000.00) TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2016 FOR THE ACCOUNT-TRAVELLING EXPENSE - FOREIGN (5-02-01-020) OF THE OFFICE OF THE CITY MAYOR.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc in Regular Session assembled, That:

SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of EIGHT HUNDRED THOUSAND PESOS (P800,000.00)of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the account-Travelling Expense- Foreign of the Office of the City Mayor to be taken from the Unappropriated Surplus, End of Year, 2016.

SECTION 2. <u>EFFECTIVITY</u>. This Appropriation Ordinance shall take effect immediately upon its approval.
