PREFATORY STATEMENT

WHEREAS, submitted to the 14<sup>th</sup> Sangguniang Panlungsod ng Ormoc for consideration is an Endorsement dated November 15, 2017 from the City Mayor Richard I. Gomez pertaining to the request of City Engr. Ranulfo D. Oliveros for a supplemental appropriation in the total amount of One Million Four Hundred Seventy Five Thousand Six Hundred Fourteen Pesos & 63/100 (P1,475,614.63) chargeable against the Unappropriated Surplus, End of Year 2016 of the General Fund;

WHEREAS, the requested appropriation is intended to supplement the appropriation for the Construction/Repair/Improvement and Renovation of Socio-Cultural and Sports Development Facilities ( Covered Court/ Evacuation Center and Facilities) of the following barangays, to wit:

WHEREAS, to recollect, this Sanggunian had earlier appropriated the amount of THIRTY NINE MILLION TEN THOUSAND PESOS (P39,010,000.00) for the construction of covered courts in the above named barangays as per Appropriation Ordinance No. 2016-020 enacted on December 15, 2016;

WHEREAS, as laid down in the letter request of the City Engineer, there are necessary additional works that need to be undertaken with respect to the Construction of Covered Courts in the aforementioned barangays which were not included during the projects' pre-evaluation thus, the need to have additional appropriation to ensure the timely completion of the same;

WHEREAS, the required funds for the purpose totaling to One Million Four Hundred Seventy Five Thousand Six Hundred Fourteen Pesos & 63/100 (P1,475,614.63) is deemed available as certified by the City Budget Officer, City Treasurer and OIC- City Accountant as contained in a Certification dated 19 October 2017 to be taken from the Unappropriated Surplus, end of Year 2016 of the General Fund;

WHEREAS, this august Body finds the supplemental budget request to be in order and truly desirable to make certain that the subject infrastructure projects will be completed the earliest time so that it can be put to use by the concerned barangays not only as venues for various socio-cultural and sports related activities, but to serve also as evacuation places during disasters and other emergency situations;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Mario M. Rodriguez, Chairman, Committee on Finance & Appropriation, severally seconded by SP Members Tomas R. **AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE MILLION FOUR HUNDRED SEVENTY FIVE THOUSAND SIX HUNDRED FOURTEEN PESOS & 63/100 (P1,475,614.63) TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2016 OF THE GENERAL FUND AS ADDITIONAL APPROPRIATION FOR THE CONSTRUCTION/REPAIR/IMPROVEMENT AND RENOVATION OF SOCIO- CULTURAL AND SPORTS DEVELOPMENT FACILITIES (COVERED COURT/ EVACUATION CENTER AND FACILITIES) OF THE FOLLOWING BARANGAYS, TO WIT:**

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc in Regular Session assembled, That:

**SECTION 1. 2017 GENERAL FUND SUPPLEMENTAL BUDGET.** The sum of ONE MILLION FOUR HUNDRED SEVENTY FIVE THOUSAND SIX HUNDRED FOURTEEN PESOS & 63/100 (P1,475,614.63) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated as additional funds for the Construction/Repair/Improvement and Renovation of Socio- cultural and Sports Development Facilities ( Covered Court/ Evacuation Center and Facilities) of the afore enumerated barangays to be taken from the Unappropriated Surplus, End of Year, 2016 of the General Fund.

**SECTION 2. EFFECTIVITY.** This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
