PREFATORY STATEMENT

WHEREAS, presented to the 14th Sangguniang Panlungsod ng Ormoc for consideration is an Endorsement dated December 19, 2017 from the Office of the covering the request of Ms. Ma. Elena E. Mendoza, Acting-City for a supplemental appropriation amounting to FOUR MILLION City Mayor Agriculturist, for a THREE HUNDRED FIFTEEN THOUSAND TWO HUNDRED TWENTY-SIX PESOS (P4,315,226.00) to fund the project - Provision of Equipment and Other Related Materials for Soil and Plant Tissue Analysis Laboratory Operations of the City Agriculture Office (CAO);

WHEREAS, the CAO will be setting up a Soil and Plant Tissue Laboratory at its New Agri-tech Building in Barangay San Pablo, primarily to meet the soil testing and plant tissue analysis needs in the localities;

WHEREAS, Soil and Plant Tissue analysis is a valuable tool in determining the nutritional status of crops and provides the grower with necessary information about the pH level and the nutrients available in the soil, as well as possible nutritional deficiency in plants hence, deemed an important facility that will contribute to increased agricultural production and income to the local farmers;

WHEREAS, the Provision of Equipment and Other Related Materials for Soil and Plant Tissue Analysis Laboratory of the City Agriculture Office (CAO) is considered a priority to make it fully operational and capable of providing the necessary services and deliver the expected outputs for which the subject laboratory is established;

WHEREAS, the City Budget Officer, City Treasurer and OIC- City Accountant issued a Certification dated December 19, 2017 stating therein that the amount requested totaling to FOUR MILLION THREE HUNDRED FIFTEEN THOUSAND TWO HUNDRED TWENTY-SIX PESOS (P4,315,226.00) to carry out the aforementioned project of the City Agriculture Office is deemed available chargeable against the Unappropriated Surplus, end of Year 2016 of the General Fund;

RESOLVED, AS IT IS HEREBY RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2017-030 (General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF FIFTEEN FOUR MILLION THREE HUNDRED THOUSAND TWO HUNDRED TWENTY-SIX PESOS (P4,315,226.00) TO BE TAKEN FROM OUT OF THE UNAPPROPRIATED SURPLUS, END OF YEAR 2016 OF THE GENERAL FUND FOR THE PROVISION OF EQUIPMENT AND OTHER RELATED MATERIALS FOR SOIL AND PLANT TISSUE ANALYSIS LABORATORY OF THE CITY AGRICULTURE OFFICE (CAO) UNDER ACCOUNT-TECHNICAL AND SCIENTIFIC THE EQUIPMENT.

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc in Regular Session assembled, That:

SECTION 1.2017 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of FOUR MILLION THREE HUNDRED FIFTEEN THOUSAND TWO HUNDRED TWENTY-SIX PESOS (P4,315,226.00) of the General Fund Supplemental Budget of Ormoc City is hereby appropriated for the Provision of Equipment and other related materials for the Soil and Plant Tissue Analysis Laboratory of the City Agriculture Office (CAO) to be taken from the Unappropriated Surplus, end of year 2016 of the General Fund.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
