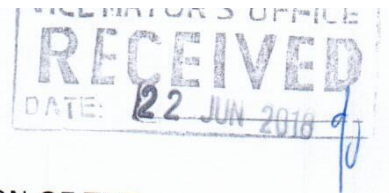

PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of a 2nd Endorsement Letter from the City Mayor's Office (CMO), dated May 29, 2018, providing therein a request for a Supplemental Appropriation in the total amount of THREE MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP3,500,000.00) to be taken from Unappropriated Surplus, End of Year 2017, for the Improvement of the Terminal, specifically the public toilet of the Ormoc City Public Transport Terminal 1 (Jeepney Terminal) with a provision of facilities for Persons with Disabilities (PWDs);

WHEREAS, the current state of the subject public toilet is in need of a serious and urgent response for its improvement and upgrade considering that only a few dilapidated toilets are usable and available for the use and convenience of the numerous commuters in both terminals of the Ormoc City Public Transport Terminal;

WHEREAS, the City Budget Officer, the OIC-City Accountant and City Treasurer issued a Certificate of Availability of Funds, dated May 24, 2018, a copy of said certification is attached as Annex "A" and made an integral part hereof, stating therein that the amount of THREE MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP3,500,000.00) is deemed available to be taken from the Unappropriated Surplus, End of Year 2017 for the Construction/Rehabilitation/Improvement of Other Public Buildings and Facilities - Improvement of Terminal (Public Toilet with PWD Facility);

WHEREAS, the request is deemed reasonable and meritorious as it is geared towards the improvement of public infrastructure and public sanitation facility in the City of Ormoc for the benefit of the commuting public and general public, specifically to Persons with Disabilities (PWD), and not contrary to existing accounting and auditing laws, rules and regulations;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Mario M. Rodriguez, Chairman, Committee on Finance & Appropriation, severally seconded by SP Members Vincent L. Rama, Eusebio Gerardo S. Penserga, Tomas R. Serafica, Benjamin S. Pongos, Jr., Nolito M. Quilang, John Eualio Nepomcueno O. Aparis III and Mariano Y. Corro: be it

RESOLVED, AS IT IS HEREBY RESOLVED, to enact:

APPROPRIATION ORDINANCE NO. 2018-012
(General Fund)

AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP3,500,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2017 FOR THE IMPROVEMENT AND REHABILITATION OF THE ORMOC CITY PUBLIC TRANSPORT TERMINAL 1 (JEEPNEY TERMINAL) PUBLIC TOILET WITH FACILITIES FOR PERSONS WITH DISABILITIES (PWD).

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod ng Ormoc in Regular Session assembled, that:

SECTION 1. 2018 GENERAL FUND SUPPLEMENTAL BUDGET. The total amount of THREE MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP3,500,000.00) to be taken from the Unappropriated Surplus, End of Year 2017 is hereby appropriated to fund the Improvement and Rehabilitation of the Ormoc City Public Transport Terminal-Terminal 1 (Jeepney Terminal) Public Toilet with Facilities for PWD.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.


RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, June 21, 2018.


