PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of a 2nd Endorsement Letter from the Office of the City Mayor (CMO), dated May 28, 2018, providing therein a request of Engr. Fulton Emmanuel S. Manawatao, Acting Head of Office-Ormoc WaterWorks Office (ORWASA), for the Reversion of Funds in the total amount of TWO MILCION TWO HUNDRED NINETY SEVEN THOUSAND SIX HUNDRED SEVENTY SIX PHILIPAINE PESOS & 14/100 (PHP2,297,676.14) to be taken from the following completed projects/unimplemented projects as listed below, to wit:

WHEREAS, the funds subject for reversion will be utilized to supplement the Maintenance and Other Operating Expenses (MOOE) account-Other Supplies and Materials Expenses of ORWASA relative to the urgency of purchasing new and modern water meters as replacement of the defective and antiquated water meters of the City;

WHEREAS, on April 12, 2018, Ordinance No. 064 S. 2018 was passed by the Sangguniang Panlungsod to address, among others, the issue of non-revenue of water service provided by ORWASA to the City consumers because of the numerous number of defective and antiquated water meters hence, the replacement of over twenty two thousand (22,000) old units of water meters currently in use by ORWASA consumers with new and modern water meters is considered expedient to achieve the desired increase of the City's water revenue;

WHEREAS, for the effective implementation of the said Ordinance, ORWASA will need funds in the initial purchase of one thousand (1,000) units of new and modern water meters to be used as replacement of the old and defective water meters and for the installation of "new services" of ORWASA;

WHEREAS, the City Budget Officer, the OIC-City Accountant and City Treasurer issued a Certificate of Availability of Funds, dated May 14, 2018, a copy of said certification is attached as Annex "A" and made an integral part hereoi, stating therein that the amount of TWO MILLION TWO HUNDRED NINETY SEVEN THOUSAND SIX HUNDRED SEVENTY SIX PHILLIPPINE PESOS & 14/100 (PHP2,297,676.14) for the purchase of water meters under the account - Other Supplies and Materials Expenses is deemed available to be taken from reversion of the following Continuing Appropriations, to wit. (1) Installation of Pipelines at Brgy. Can-untog-2012 (PHP18,123.26); (2) Installation of Pipelines at Brgy. Milagro, Dolores, Luna, San Pablo, Dayhagan, Juaton & Concepcion-2015 (PHP267,508.61); (3) Installation of Flow Meters at Ahag Gallery Filtration, Carlos Tan etc.-2016 (PHP2,000,000.00); and (4) Construction of Water Intake Structure of River Control at Brgy. Patag -2017 (PHP2,000,000.00);

WHEREAS, the request is deemed reasonable and meritorious as it is geared towards the improvement of efficiency in the collection of revenue of water services and improvement of the delivery of services to the consumers of ORWASA, and not contrary to existing accounting and auditing laws, rules and regulations;

SECTION 1. <u>2018 GENERAL FUND SUPPLEMENTAL BUDGET</u>. The total sum of TWO MILLION TWO HUNDRED NINETY SEVEN THOUSAND SIX HUNDRED SEVENTY SIX PHILIPPINE PESOS & 14/100 (PNP2,297,676.14) is hereby reverted and appropriated to supplement the account Other Supplies and Materials Expenses of the Ormoc Waterworks Office (ORWASA) for the purchase of brand new and modern water meters.

SECTION 2. EFFECITIVITY This Appropriation Ordinance shall take effect immediately upon its approval.
