PREFATORY STATEMENT

WHEREAS, the Sangguniang Panglungsod was in receipt of an Endorsement Letter from the City Mayor's Office (CMO), dated July 9, 2018, requesting for a Supplemental Appropriation in the total amount of FORTY MILLION PHILIPPINE PESOS (PHP40,000,000.00) for the Construction/Rehabilitation/Improvement of Other Public Buildings & Facilities (Construction of Multi-Purpose Hall at Ormoc City Central School);

WHEREAS, the construction of the two-level covered Multi-Purpose Hall, with a total floor area of One Thousand One Hundred Sixteen (1,116) square meters, is not only for the purpose of providing a venue for the athletes and sports enthusiasts in the City of Ormoc to practice and hone their athletic talent and skills, but also for the purpose of providing the city an additional venue to hold various sports activities, including indoor sports, and the same may also be used as an evacuation site in cases of emergency in the area surrounding it;

WHEREAS, the City Budget Officer, the City Accountant and City Treasurer issued a Certificate of Availability of Funds, dated July 4, 2018, stating therein that the amount of FORTY MILLION PHILIPPINE PESOS (PHP40,000,000.00) is deemed available chargeable against the Unappropriated Surplus, end of year 2017 for the Const./Rehab/Improvement of Other Public Buildings & Facilities (Construction of Multi-Purpose Hall @ Ormoc City Central School);

WHEREAS, the request of the City Mayor's Office is justified and deemed reasonable and meritorious as it is geared towards the improvement and betterment of the city's public facilities through the construction of a sports facility specifically for the benefit and use of the city's athletes, its constituents, and the general public, and not contrary to existing accounting and auditing laws, rules and regulations;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Mario M. Rodriguez, Chairman, Committee on Finance & Appropriation, severally seconded by SP Members Vincent L. Rama, Tomas R. Serafica, Benjamin S. Pongos, Jr., Gregorio G. Yrastorza III, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II, Esteban V. Laurente and Jasper C. Yerro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to enact:

**APPROPRIATION NO. 2018-016
(General Fund)**

AN ORDINANCE APPROPRIATING THE AMOUNT OF FORTY MILLION PHILIPPINE PESOS (PHP40,000,000.00) TO BE TAKEN FROM THE UNAPPROPRIATED SURPLUS, END OF YEAR 2017 FOR THE ACCOUNT CONSTRUCTION/ REHABILITATION/ IMPROVEMENT OF OTHER PUBLIC BUILDINGS AND FACILITIES (CONSTRUCTION OF A MULTI-PURPOSE HALL AT ORMOC CITY CENTRAL SCHOOL).

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod of Ormoc in Regular Session assembled, that:

SECTION 1. CY 2018 GENERAL FUND SUPPLEMENTAL BUDGET. The total sum of FORTY MILLION PHILIPPINE PESOS (PHP40,000,000.00) to be taken from Unappropriated Surplus, End of Year 2017 is hereby appropriated to fund the Construction of a Multi-Purpose Hall at Ormoc City Central School.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.


RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

ENACTED, August 09, 2018.

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to the City Mayor Richard I. Gomez; the City Administrator, Mr. Vincent L. Emnas; the City Legal Officer, Atty. Jasper M. Lucero; the City Engineer, Engr. Ranulfo D. Oliveros; the City Budget Officer; the City Accountant; the City Treasurer; the City Auditor; the OIC-City Director, DILG, Engr. Jesus Jeremy D. Bagares; and other offices concerned;

CARRIED by Nine (9) Affirmative Votes. SP Member Vincent L. Rama was out of the Session Hall at the time of the voting.
