PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an Endorsement Letter from the City Mayor's Office (CMO), dated September 20, 2018, respectfully endorsing the request of Jose Arnil C. Corong, DVM, Veterinarian IV, Siaughterhouse Division, for the Reversion of Funds in the total amount of TWO HUNDRED NINE THOUSAND FIVE HUNDRED FORTY-SIX PESOS & 11/100 (PHP209,546.11) for the purchase of the following items: (i) one (1) unit of Photocopier Machine; (ii) one (1) unit of Air-condition, window type 1.5 HP; and (iii) one (1) unit of Air-condition, Split-Type 2.5 HP;

WHEREAS, in a committee meeting conducted by the Committee on Finance and Appropriation on October 16, 2018 at the SP Session Hall, it was recommended that adjustments of the items sought to be purchased should be made relative to its specifications and capabilities that shall likewise meet the actual demands of the subject office;
