


PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an Endorsement Letter from the City Mayor's Office, dated October 16, 2018, respectfully endorsing the request of Mr. Rafael Junnar P. Dumalan, Environmental Management Specialist II, for the Reversion of Funds in the total amount of ONE HUNDRED THOUSAND PHILIPPINE PESOS (PHP100,000.00) which may be taken from the reversion of Current Appropriation under account - Other Property, Plant and Equipment - of the Environment and Natural Resources Office (ENRO), to wit:

WHEREAS, the requested reversion is for the purpose of purchasing one (1) unit of motorcycle in order to facilitate, among other purposes, the monitoring and assessment of Sand and Gravel activities in remotely located permitted areas by the requesting office;

WHEREAS, the City Budget Office, the City Accountant and City Treasurer issued a Certification of Availability of Funds dated October 12, 2018 stating therein that the amount of ONE HUNDRED THOUSAND PHILIPPINE PESOS (PHP100,000.00) is deemed available to be taken from reversion of Current Appropriation under account - Other Property, Plant and Equipment - of the ENRO, a copy of said certification is attached as Annex "A" and made an integral part hereof;

WHEREAS, this Sanggunian finds that the endorsed request for the reversion of funds is justified, reasonable and meritorious as it is geared towards the augmentation of the capability of the ENRO and its personnel in continually monitoring and assessing sand and gravel activities in accordance with Philippine mining laws, and other purposes, that would redound to the benefit of the city and its constituents;

SECTION 1. CY 2018 GENERAL FUND SUPPLEMENTAL BUDGET. The amount of ONE HUNDRED THOUSAND PHILIPPINE PESOS (PHP100,000.00) from the Current Appropriation account - Other Property, Plant and Equipment of the ENRO is hereby reverted and appropriated for the purchase of one (1) unit of motorcycle.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.
