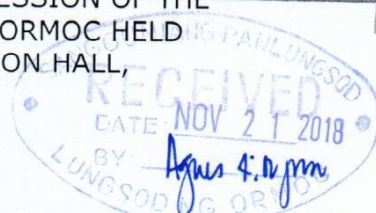
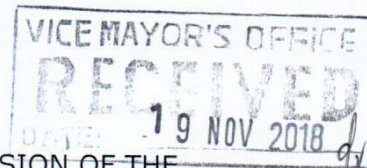

PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an extremely urgent Endorsement Letter from the City Mayor's Office, dated October 29, 2018, endorsing the request of Engr. Rodolfo H. Labarda, Jr., Acting Market Administrator, for the Reversion of Funds in the amount of THREE MILLION PHILIPPINE PESOS (PHP3,000,000.00) for the purpose of the allotment of wages of Job Order personnel assigned at the Public Market Office until December 2018 and TWO HUNDRED THREE THOUSAND PHILIPPINE PESOS (PHP203,000.00) for the Construction of Fish Vendor's Shed (Alpor) at Bagsakan, Brgy. Alegria, Ormoc City, with the total amount of THREE MILLION TWO HUNDRED THREE THOUSAND PHILIPPINE PESOS (PHP3,203,000.00) which may be taken from reversion of Continuing Appropriations of Market Office;

WHEREAS, the Sangguniang Panlungsod was in receipt of an endorsement letter from the City Mayor's Office, dated November 7, 2018, endorsing the request of Engr. Rodolfo H. Labarda, Jr., Acting Market Administrator, for the withdrawal of the request for Reversion of Funds for the Construction of Alpor Shed at the Bagsakan Area due to discrepancies of the Program of Works resulting to inaccurate figures on its project cost;

WHEREAS, with the withdrawal of the second item of the Endorsement Letter dated October 29, 2018, this appropriation ordinance shall pertain solely to the Reversion of Funds in the amount of THREE MILLION PHILIPPINE PESOS (PHP3,000,000.00) for the purpose of the allotment of wages of Job Order personnel assigned at the Public Market Office until December 2018;

WHEREAS, the Public Market Office has an appropriation of NINE MILLION PHILIPPINE PESOS (PHP9,000,000.00) under the account Maintenance and Other Operating Expense CY 2018 for the payment of the wages of Job Order personnel under the Public Market Office. However, such appropriation was already depleted, hence, this request for additional funds to ensure that the wages of these Job Order Personnel be appropriately paid until the end of December 2018.

WHEREAS, the City Budget Office, the City Accountant and City Treasurer issued a Certification of Availability of Funds dated November 13, 2018 stating therein that the amount of THREE MILLION PHILIPPINE PESOS (PHP3,000,000.00) to fund the wages for Job Orders of same office is deemed available to be taken from reversion of Continuing Appropriation accounts – Other Machineries and Equipment 2015 and Office Equipment 2015 of the Public Market Office, a copy of said certification is attached as Annex "A" and made an integral part hereof;

WHEREAS, this Sanggunian finds that the endorsed request for the reversion of funds is justified, reasonable and meritorious as it will be for the just payment of the wages of Job Order personnel of the Public Market Office who are all necessary for the non-interruption and continuous delivery of services of the Local Government of Ormoc to the public;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Benjamin S. Pongos, Jr., Vice-Chairman, Committee on Finance & Appropriation, duly seconded by SP Member Vincent L. Rama; be it

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF THREE MILLION PHILIPPINE PESOS (PHP3,000,000.00) FOR THE PAYMENT OF WAGES OF JOB ORDER PERSONNEL UNDER THE PUBLIC MARKET OFFICE UNTIL DECEMBER 2018 TO BE TAKEN FROM CONTINUING APPROPRIATIONS OF THE SAME OFFICE, TO WIT:

BE IT ENACTED, by the Fourteenth Sangguniang Panlungsod of Ormoc in Regular Session assembled, that:

SECTION 1. CY 2018 GENERAL FUND SUPPLEMENTAL BUDGET. The amount of THREE MILLION PHILIPPINE PESOS (PHP3,000,000.00) to be taken from the aforementioned Continuing Appropriations of the Public Market Office is hereby reverted and appropriated for the payment of the wages of Job Order personnel until December 2018.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.



Bagares; and other offices concerned;
