## PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an urgent Endorsement Letter from the City Mayor's Office, dated December 10, 2018, respectfully requesting for a Supplemental Appropriation in the total amount of EIGHT MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP8,500,000.00) chargeable against the Unappropriated Surplus, End of Year 2017, of the General Fund for the following projects, to wit:

Road Network: Road Concreting and Widening @ Brgy. Alegria-Batuan PHP5,500,000.00

Other Land Improvement:

Construction of Pre-Cast Concrete Pathway at:

a) Lower Mandaang to Upper Mandaang,

Brgy. Sabang Bao

b) Purok Lemonsito, Brgy. Sabang Bao, Ormoc City PHP1,000,000.00

WHEREAS, to accommodate the expected increase in vehicle and foot traffic from the newly opened and inaugurated Alegria II Bridge at Brgy. Alegria, the existing road starting from the Alegria II Bridge at Brgy. Alegria to Brgy. Batuan shall be concreted and widened to 6.1 meters with two (2) pieces of concrete box culverts, and concrete drainage with concrete cover, curb and gutter, all for an estimated cost of FIVE MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP5,500,000.00);

WHEREAS, a One Thousand (1,000) meter pre-cast concrete pathway will be constructed from Lower Mandaang to Upper Mandaang, Brgy. Sabang Bao, with an estimated cost of TWO MILLION PHILIPPINE PESOS (PHP2,000,000.00);

WHEREAS, a Five Hundred (500) meter pre-cast concrete pathway will be constructed @Purok Lemonsito, Brgy. Sabang Bao immediately after the existing hanging bridge, with an estimated cost of ONE MILLION PHILIPPINE PESOS (PHP1,000,000.00);

WHEREAS, the City Budget Office, the City Accountant, and City Treasurer issued a Certification of Availability of Funds dated December 6, 2018 stating therein that the amount of EIGHT MILLION FIVE HUNDRED THOUSAND PHILIPPINE PESOS (PHP8,500,000.00) for the construction of abovementioned Infrastructure Projects is deemed available to be taken from the Unappropriated Surplus End of Year 2017, of the General Fund, a copy of said certification is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, this Sanggunian finds that the endorsed request for supplemental appropriation is justified, reasonable and meritorious as it is geared towards the improvement of existing public infrastructure and for the construction of new road networks that will ultimately redound to the benefit of the constituents of Ormoc and the general public, and not contrary to existing accounting, auditing laws, rules and regulations;
