PREPARATORY STATEMENT

WHEREAS, the Sangguniang Panglungsod was in receipt of an Endorsement Letter dated March 21, 2019 from the Office of the City Mayor (CMO) respectfully requesting for Supplemental Appropriation in the total arnount of THIRTY MILLION PHILIPPINE PESOS (PHP30,000,000.00) chargeable against the Unappropriated Surplus, and further requesting that this matter be treated as urgent;

WHEREAS, requested for supplemental appropriation will be used to augment the following accounts of the City Mayor's Office, to wit:

WHEREAS, the account of Sports Development Program of the City Mayor's Office (CMO), specifically for Other Supplies and Materials Expenses, Prizes, and Other Maintenance and Operating Expenses with an aggregate appropriation of ELEVEN MILLION PHILIPPINE PESOS (PHP11,000,000.00), as contained in the 2019 Annual Budget of the City, has, as of April 4, 2019, a remaining aggregate balance of only approximately FOUR HUNDRED THOUSAND PHILIPPINE PESOS (PHP400,000.00);

WHEREAS, the account of Community & School/Education Aid Program of the CMO with an appropriation of TWELVE MILLION PHILIPPINE PESOS (PHP12,000,000.00) as contained in the 2019 Annual Budget of the City has, as of April 3, 2019, a remaining balance of only SEVEN HUNDRED EIGHTEEN THOUSAND THREE HUNDRED NINETY-FOUR PHILIPPINE PESOS (PHP718,394.00);

WHEREAS, the respective balances of the above-enumerated accounts under the Sports Development Program and Community & School/Education Aid Program are deemed insufficient to fund anticipated expenses of the CMO;

WHEREAS, the account Capital Outlay – Motor Vehicles of the City Mayor's Office with an appropriation of THREE MILLION PHILIPPINE PESOS (PHP3,000,000.000) is also deemed insufficient especially in consideration of the numerous requests for vehicles of various offices and departments of the local government;

WHEREAS, abovementioned supplemental appropriation in the total amount of THIRTY MILLION PHILIPPINE PESOS (P/P30,000,000.00) shall be chargeable against the Unappropriated Surplus of the city declared as Savings in LEP Form No. 8, Statement of Funding Sources duly signed by Ms. Alicia Dimapingun, OIC-City Treasurer; and Mrs. Rosario G. Serafica, City Accountant, a copy of said form is attached herein as Annex "A" and made an integral part hereof;

WHEREAS, this Sanggunian finds that the said request for a Supplemental Appropriation in the total amount of THIRTY MILLION PHILIPPINE PESOS (PHP30,000,000.00) for various Maintenance and Other Operating Expenses accounts and Capital Outlay – Motor Vehicles account of the CMO needs to be reduced to TWENTY MILLION PHILIPPINE PESOS (PHP20,000,000.00) because the request for Capital Outlay – Motor Vehicles lacks some supporting documents while the other objects of the request are found to be justified, reasonable, necessary and should be urgently given due consideration to avoid delay in the implementation of future various city programs, projects and activities;
