PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an urgent Endorsement Letter from the City Mayor's Office (CMO), dated July 16, 2019, requesting for a Supplemental Appropriation in the total amount of Six Million Nine Hundred Thousand Philippine Pesos (Php 6,900,000.00) for the implementation of various projects chargeable against the Reversion of General Fund Continuing Appropriations;

WHEREAS the OIC-City Treasurer and City Accountant issued LBP Form No. 8- Statement of Funding Sources FY 2019 showing therein that the requested amount of Six Million Nine Hundred Thousand Philippine Pesos (Php 6,900,000.00) be taken from the Reversion of General Fund Continuing Appropriations, a copy of which is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the reverted amount will be used to augment the following accounts as indicated in LBP Form No. 9 issued by the City Mayor and City Budget Officer, a copy of said form is attached hereto as Annex "B" and made an integral part hereof, to wit:

WHEREAS, during the committee meetings conducted by the Committee on Finance and Appropriation on July 18, 2019 and August 14, 2019 to discuss the subject matter, the committee respectfully requested for a copy of the Program of Works for the projects to be implemented by the Slaughterhouse to which the latter was not able to comply as the Program of Works is still for completion by the said office. Thus, the committee previously declined the reversion request of Three Million Seven Hundred Thousand Philippine Pesos (Php 3,700,000.00) towards the account of Building and Other Structures: Slaughterhouse due to lack of supporting documentation.

WHEREAS, the amount approved for the appropriation request was adjusted from of Six Million Nine Hundred Thousand Philippine Pesos (Php 6,900,000.00) to Three Million Two Hundred Thousand Philippine Pesos (Php 3,200,000.00) for the projects of ENRO and CAO only, chargeable against the Reversion of General Fund Continuing Appropriations as per Appropriation Ordinance No. 008 Series of 2019;

WHEREAS, the Slaughterhouse was now able to comply and furnished the Sanggunian with their program of works amounting to Two Million Seven Hundred Thousand Philippine Pesos (P2,700,000,00) for the projects intended for the Rehabilitation of the Water Storage Tank, the construction of Washing/Parking Area and Motorshop as well as supply and installation of two (2) units of Stainless Steel Grating Table.

WHEREAS, the amount approved for the appropriation request was adjusted from Three Million Seven Hundred Thousand Philippine Pesos (P3,700,000.00) to Two Million Seven Hundred Thousand Philippines Pesos (Php2,700,000.00).

WHEREAS, this Sanggunian finds that the requested supplemental appropriation Slaughterhouse is justified and deemed reasonable and meritorious as the aforementioned programs & projects are deemed most beneficial to the public and the procurement of necessary supplies and equipment will augment the implements of the said office furthering the office's efficacy and effectiveness in the rendering of their services to the public;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Peter M. Rodriguez, Chairman, Committee on Finance & Appropriation, severally seconded by SP Members Nolito M. Quilang, Vincent L. Rama, Gregorio G. Yrastorza III, Esteban V. Laurente and Jasper C. Yerro: be it

AN ORDINANCE REVERTING AND APPROPRIATING THE AMOUNT OF TWO MILLION SEVEN HUNDRED THOUSAND PHILIPPINE PESOS (PHP2,700,000.00) FOR THE IMPLEMENTATION OF SLAUGHTERHOUSE PROJECTS CHARGEABLE AGAINST THE REVERSION OF GENERAL FUND CONTINUING APPROPRIATIONS, TO WIT:

SECTION 1. CY 2019 GENERAL FUND SUPPLEMENTAL BUDGET. The total sum of TWO MILLION SEVEN HUNDRED THOUSAND PHILIPPINE PESOS (Php2,700,000.00) is hereby reverted and appropriated for the implementation of Slaughterhouse projects chargeable against the reversion of general fund continuing appropriations.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
