# PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an endorsement letter from the City Mayor's Office (CMO) requesting for a Reversion of Funds for the total amount of Thirty-Three Million Two Hundred Thirty Thousand Philippine Pesos (PHP 33, 230,000.00) to be taken from the Continuing Appropriation of the City General Services Office (GSO) and a Supplemental Appropriation in the amount of Seven Million Five Hundred Twenty Thousand Philippine Pesos (PHP 7,520,000.00) to be taken from the City's Unappropriated Surplus, End of Year of 2018 in the total amount of Forty Million Seven Hundred Fifty Thousand Philippine Pesos (PHP 40,750,000.00) for the purchase of brand new Landfill Compactor and Tractor Head of the Environment and Natural Resources Office (ENRO);

WHEREAS, the amount is to be taken from the City's Unappropriated Surplus, End of Year 2018 and reversion from the Continuing Appropriation of the City General Services Office, as stated in the LBP Form No.8 - Statement of Funding Sources, FY 2019, issued by the OIC-City Treasurer and the City Accountant, a copy of which is hereto attached and designated as Annex "A" hereof, to wit:

WHEREAS, the purpose of the supplemental appropriation and reversion is for the purchase of one (1) new Landfill Compactor and one (1) Tractor Head necessary for the function and duty implementation of the ENRO;

WHEREAS, the total purchase cost of the two Heavy Duty Equipment totaled to Forty-Six Million Nine Hundred Fifty Thousand Philippine Pesos (PHP 46,950,000.00) and with only Six Million Two Hundred Thousand Philippine Pesos (PHP 6,200,000.00) balance on their Heavy Equipment Purchase Account, they opted for a fund reversion from the General Services Office for the total amount of Thirty-Three Million Two Hundred Thirty Thousand Philippine Pesos (PHP 33, 230,000.00) and a Supplemental Appropriation request in the amount of Seven Million Five Hundred Twenty Thousand Philippine Pesos (PHP 7,520,000.00) to be taken from the City's Unappropriated Surplus, End of Year 2018, to cover the purchase cost of the two equipment;
