PREFATORY STATEMENT

WHEREAS, the 15th Sangguniang Panlungsod was in receipt of the FY 2020 Executive Budget of the City of Ormoc for consideration for both the General Fund and Operations of the Local Economic Enterprises (LEEs) in the total amount of ONE BILLION SIX HUNDRED TWENTY-ONE MILLION SEVEN HUNDRED FORTY-TWO THOUSAND ONE HUNDRED NINETY-NINE PHILIPPINE PESOS (PHR1,621,742,199,00);

WHEREAS, the FY 2020 Annual Executive Budget provides for the priority programs and projects of the city as per approved Annual Investment Plan (AIP) and its formulation is anchored on the goal of initiating changes that respond to the clamor for a more participatory form of government, increased transparency and public accountability in government operations, and improved quality of public service;

WHEREAS, the proposed FY 2020 Annual Executive Budget shall be sourced out from both national and local sources which are allocated in accordance with the general guidelines set under Local Budget Memorandum No. 78 dated May 15, 2019 summarized as follows:

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE BILLION SIX HUNDRED TWENTY-ONE MILLION SEVEN HUNDRED FORTY-TWO THOUSAND ONE HUNDRED NINETY-NINE PHILIPPINE PESOS (PHP1,621,742,199.00) AS FY 2020 ANNUAL BUDGET OF THE CITY OF ORMOC FOR BOTH GENERAL FUND AND THE OPERATIONS OF LOCAL ECONOMIC ENTERPRISES (LEES) SUMMARIZED AS FOLLOWS:

BE IT ENACTED, by the Fifteenth Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. <u>2020</u> <u>ANNUAL BUDGET</u>. The Annual Budget for both the General Fund and Operations of LEEs of Ormoc City for Fiscal Year 2020 involving an appropriation of ONE BILLION SIX HUNDRED TWENTY-ONE MILLION SEVEN HUNDRED FORTY-TWO THOUSAND ONE HUNDRED NINETY-NINE PHILIPPINE PESOS (PHP1,621,742,199.00) for the priority programs and projects therein specified to be taken from out of the estimated income certified as reasonably collectible in the aggregate sum of ONE BILLION SIX HUNDRED TWENTY-ONE MILLION SEVEN HUNDRED FORTY-TWO THOUSAND ONE HUNDRED TWENTY-ONE MILLION SEVEN HUNDRED FORTY-TWO THOUSAND ONE HUNDRED NINETY-NINE PHILIPPINE PESOS (PHP1,621,742,199.00) be as it is hereby, APPROVED.

SECTION 2. SPECIAL PROVISIONS.

I. General Provision:

1. Use of Savings and Augmentations. In accordance with Section 336 of Republic Act 7160, the Local Government Code of 1991, the Local Chief Executive and the Presiding Officer of the Sanggunian are authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

II. Specific Provisions:

1. That, the respective appropriations under these various expense class of the following offices: City Treasurer's Office, Human Resource Management Office, City Social Welfare and Development Office and City Health Department, as enumerated hereunder be adjusted as follows:
