PREFATORY STATEMENT

WHEREAS, presented to the Fifteenth Sangguniang Panlungsod for consideration is an urgent Indorsement dated March 27, 2020 from the City Mayor Richard I. Gomez requesting for a supplemental appropriation in the total amount of THIRTY TWO MILLION FIFTY THOUSAND PHILIPPINE PESOS (PHP32,050,000.00) for the Direct Subsidy to Electric Consumers with monthly consumption of 100kWh and below for Calendar Year 2015-2018 broken down as follows:

PHP 9,947,028.00 10,092,492.53 11,493,774.23 8,537,394.72

PHP40,070,689.48 x 80% = PHP 32,056,551.58

WHEREAS, the Republic Act 7160 otherwise known as the Local Government Code provides that at least eighty percent (80%) of the proceeds derived from the development and utilization of hydrothermal, geothermal, and other sources of energy shall be applied solely to lower the cost of electricity in the local government unit where such a source of energy is located including sharing the same with the inhabitants by way of direct benefits/ subsidies;

WHEREAS, it is mandated by RA 9513 (Renewable Energy Law) specifically Section 21.B of its Implementing Rules and Regulations (IRR) which states " Eighty Percent (80%) of the share from the Royalty and/or government share of the Renewable Energy (RE) Host community/LGUs from RE Projects and activities shall be used directly to "subsidize the electric consumption of end users in the RE host communities/LGUS whose monthly consumption do not exceed One Hundred Kilowatt Hours (100 kWh)";

WHEREAS, the supplemental request for Direct Subsidy to Electric Consumers is deemed to be of great help to qualified constituents of Ormoc City especially in the light of the President Proclamation 929, Series of 2020, placing the Philippines under State of Calamity and Ormoc City Mayor Executive Order No. 38 s. of 2020 relative to precautionary measures towards the prevention of COVID-19;

WHEREAS, the request was referred to the Offices of the City Budget Officer, City Accountant and the City Treasurer for appropriate recommendations as to the funding source thereof and in this respect LBP No. 8 and LBP No. 9 were consecutively issued by the concerned offices certifying therein that the amount of THIRTY-TWO MILLION FIFTY THOUSAND PHILIPPINE PESOS (PHP32,050,000,00) to cover the total cost of compensation adjustment is available to be taken from the Share of National Wealth, attached herein as Annex "A" and "B" respectively, and made integral part hereof, to wit:

WHEREAS, the City Accountant issued a Certificate of Availability of Funds stating therein that the amount of THIRTY-TWO MILLION FIFTY THOUSAND PHILIPPINE PESOS (PHP32,050,000.00) is deemed available for the Direct Subsidy to Electric Consumers with monthly Consumption of 100kWh and below for the CY 2015 to 2018;

Whereas, Department of the Interior and Local Government (DILG) issued a Joint Memorandum Circular (JMC) No. 01 dated March 27, 2020 providing for Additional Guidelines on the utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment for the Development Projects in View of Coronavirus Disease 2019 (COVID -19) Situation, stated therein that it is highly imperative to provide additional guidelines on the use of 20% Development Fund (DF) to give LGUs greater leeway and fiexibility in the utilization of funds for their disaster preparedness and response effort to contain the spread of COVID-19, and to continue to provide basic services to the affected population;

WHEREAS, in reference to the aforementioned circular as well the Proclamation 929 (Series of 2020) of the President of the Philippines and Ormoc City Executive Order No. 38 s. 2020 any amount of the Electric Subsidy requested in excess of the amount currently allocated for Subsidies in the City Annual Investment Plan shall be taken from the Twenty Percent (20%) Development fund allocation;

WHEREAS, this august Body finds the supplemental budget request to be lawful and meritorious and is for the good and benefit of Ormoc Constituents especially in times of crisis and calamities;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of SP Member Peter M. Rodriguez, Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Tomas R. Serafica, Nolito M. Quilang, Esteban V. Laurente, Joan Marbie C. Simbajon, Vincent L. Rama and Gregorio G. Yrastorza III; be it

APPROPRIATION ORDINANCE NO. 004 (Series of 2020)

AN ORDINANCE APPROPRIATING THE AMOUNT OF THIRTY-TWO MILLION FIFTY THOUSAND PHILIPPINE PESOS (PHP 32,050,000.00) FOR THE DIRECT SUBSIDY TO ELECTRIC CONSUMERS WITH MONTHLY CONSUMPTION OF 100KWH AND BELOW FOR CALENDAR YEAR 2015-2018 TO BE SOURCED FROM THE 80% SHARE OF NATIONAL WEALTH.

BE IT ENACTED, by the Fifteenth Sangguniang Panlungsod ng Ormoc Regular Session assembled, that:

SECTION 1. 2020 <u>GENERAL FUND SUPPLEMENTAL BUDGET</u>. The sum of THIRTY-TWO MILLION FIFTY THOUSAND PHILIPPINE PESOS (PHP32,050,000.00) is hereby appropriated to fund the direct subsidy to electric consumers with monthly consumption of 100kwh and below for calendar year 2015-2018 to be sourced from the 80% Share of National Wealth.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
