PREFATORY STATEMENT

WHEREAS, Presidential Proclamation No. 922 declared a State of Public Health Emergency and capacitated government agencies and LGUs to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of COVID-19, mitigate its effects and impact to the community, and prevent serious disruption of the functioning of the government and the community;

WHEREAS, Republic Act 10121 or the DRRM Act of 2010 state that the Local Disaster Risk Reduction and Management Council (LDDRMC) shall monitor and evaluate the use and disbursement of the LDRRM Fund based on the LDRRM Plan as incorporated in the local development plans and annual work and financial plan, and upon the recommendation of the LDRRMO and approval of the sanggunian concerned, the LDDRMC may transfer the said funds to support other essential risk reduction activities;

WHEREAS, to address the need of the Bureau of Fire Protection for additional equipment to effectively respond to fire and other related incidents especially with the increasing city population and expanding city infrastructure, the City Disaster Risk Reduction and Management Council (CDRRMC) issued Resolution No. 3 approving the realignment of the 5%-2020 LDRRM Fund Budget from the Construction of One (1) Unit Evacuation Center to the purchase of One (1) Unit Fire Truck, said resolution is herein attached as Annex `C' and made integral part hereof;

WHEREAS, the CDRRMC also issued Resolution No. 4 approving the realignment of the 5%-2020 LDRRM Fund Budget from the Construction of CDRRM Operations Center- WASAR Substation Phase III to the purchase food and non-food items for affected communities due to the COVID-19 Outbreak, herein attached as Annex "D";

WHEREAS, the requested supplemental amount for the Welfare Goods Expenses amounting to EIGHT MILLION PHILIPPINE PESOS (PHP8,000,000.00) will need a detailed allocation breakdown from the CDRRMO thus adjusting the total approved amount from TWENTY MILLION PHILIPPINES PESOS (PHP20,000.000.00) to TWELVE MILLION PHILIPPINES PESOS (PHP12,000,000.00);

WHEREAS, the endorsement of the CMO relative to the reversion request of the CDRRMO is justified and deemed reasonable and meritorious as the proposed project is directed towards the good and benefit of the Ormoc City Constituents hence most deserving of prompt favorable action;
