WHEREAS, the Sangguniang Panlungsod was in receipt of an endorsement letter from the City Mayor's Office (CMO) dated May 21, 2020 relative to the request of Mrs. Delia D. Corbo, City Social Welfare & Development Officer, for a supplemental appropriation in the amount of ONE MILLION TWO HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,200,000.00), for payment of the Magna Carta benefits per Department of Budget and Management (DBM)-Department of Social Welfare Development (DSWD) Joint Circular (JC) No. 01, S. 2018 for Public Social Welfare Development (PSWD) Workers and for payment of overtime services for CSWDO staff;

WHEREAS, pursuant to RA 9433 otherwise known as An Act Providing for the Magna Carta for Public Social Workers, the state shall promote and improve the social and economic well-being of public social workers, their living and working conditions, and terms of employment;

WHEREAS, Section 11 of the same provides that where the exigencies of the service so require, any public social worker may be required to render service beyond the normal eight hours a day and be paid an additional compensation in accordance to existing laws;

WHEREAS, Section 15 of the same act states that public social workers assigned to report to work for areas under a state of calamity or emergency shall be entitled to Hazard Allowance equivalent to at least twenty percent (20%) of the monthly basic salary;

WHEREAS, the President issued Proclamation No. 929 declaring a State of Calamity throughout the Philippines due to Coronavirus Disease 2019 (COVID-19) wherein the Public Social Workers and CSWDO staffs are required to render additional hours in response to the urgent and immediate need for relief work in connection to the public health emergency;

WHEREAS, DBM and DSWD issued a Joint Circular Series of 2018 on the rules and regulations on the grant of compensation-related Magna Carta Benefits to Public Social Workers (PSW), Public Social Welfare & Development Worker (PSWDW);

WHEREAS, pursuant to the RA 7160 otherwise known as the "Local Government Code of 1991" the local Sanggunian is empowered to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;

WHEREAS, the request was referred to the Offices of the City Budget Officer, City Accountant, and the City Treasurer for appropriate recommendations as to the funding source thereof and in this respect LBP No. 8 and LBP No. 9 were consecutively issued by the concerned offices certifying therein that the amount of ONE MILLION TWO HUNDRED THOUSAND PHILIPPINE PESOS (PHP1,200,000.00) is deemed available for the aforementioned purpose to be taken from the Reversion of Salary Savings from Vacant Positions from January 1, 2020 to May 31, 2020, herein attached as Annex "A" and "B" respectively, to wit:
