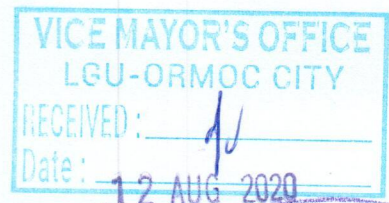
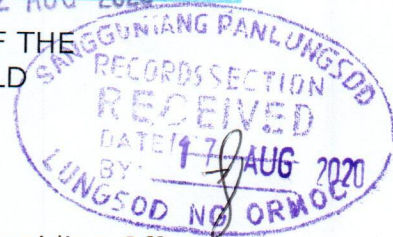

PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an urgent endorsement letter from the City Mayor's Office (CMO) dated July 30, 2020 relative to the request for reversion of funds from the 5% LDRRM Fund Budget in the amount of EIGHT MILLION PHILIPPINE PESOS (PHP8,000,000.00) for the Construction of Ormoc City Disaster Risk Reduction and Management (CDRRM) OpCen-WASAR Substation Phase III to purchase of food and non-food items for affected communities due to COVID-19 outbreak;

WHEREAS, on March 8, 2020, President Rodrigo Roa Duterte issued Proclamation No. 922, declaring a State of Public Health Emergency throughout the entire Philippines, and prompting a whole-of-government approach in addressing the COVID-19 pandemic;

WHEREAS, the Inter-Agency Task Force (IATF) issued Resolution No. 17, Series of 2020 that LGUs shall finalize the identification and refurbishing of Provincial, City, Municipal, and Barangay COVID-19 Quarantine Facilities in accordance with the guidelines issued by the DILG;

WHEREAS, CDRRM Council issued Resolution No. 4 Series of 2020 approving the realignment of the 5%-2020 LDRRM Fund budget for the construction of Ormoc City Disaster Risk Reduction and Management (CDRRM) OpCen-WASAR Substation Phase III to purchase of food and non-food items for affected communities due to COVID-19 outbreak;

WHEREAS, the amount requested is for the provision of meals to responders, frontliners, and individuals in the city's quarantine facilities;

WHEREAS, the request was referred to the Offices of the City Budget Officer, City Accountant, and the City Treasurer for appropriate recommendations as to the funding source thereof and in this respect LBP No. 8 and LBP No. 9 were consecutively issued by the concerned offices certifying therein that the amount of EIGHT MILLION PHILIPPINE PESOS (PHP8,000,000.00) is deemed available for the aforementioned purpose to be taken from the reversion of the 5% LDRRM Fund Budget for the Construction of Ormoc City DRRM OpCen-WASAR Substation Phase III, herein attached as Annex "A" and "B" respectively, to wit:

AN ORDINANCE REVERTING AND APPROPRIATING THE TOTAL AMOUNT OF EIGHT MILLION PHILIPPINE PESOS (PHP8,000,000.00) FOR THE PURCHASE OF FOOD AND NON-FOOD ITEMS IN SUPPORT TO THE AFFECTED COMMUNITIES DUE TO COVID-19 TO BE TAKEN FROM THE REVERSION OF THE 5% LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND (LDRRMF) BUDGET FOR CONSTRUCTION OF ORMOC CITY DISASTER RISK REDUCTION AND MANAGEMENT (CDRRM) OPCEN-WASAR SUBSTATION PHASE III PROJECT, THIS CITY, TO WIT:

SECTION 1. CY 2020 GENERAL FUND SUPPLEMENTAL BUDGET. The sum of EIGHT MILLION PHILIPPINE PESOS (PHP8,000,00.00) of the General Fund Supplemental Budget of Ormoc City is hereby reverted and appropriated for the purchase of food and non-food items to support the affected population due to COVID-19 to be taken from the reversion of 5% LDRRMF Budget for construction of Ormoc City DRRM OpCen-WASAR Substation Phase III Project.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.




