SECTION 1. CY 2020 GENERAL FUND SUPPLEMENTAL BUDGET. The total amount of FIFTY-FIVE MILLION TWO HUNDRED NINETY-THREE THOUSAND PHILIPPINE PESOS (PHP55,293,000.00) is hereby appropriated for payment of salaries & wages of Job Order employees under Public Employment Services Program, Casual Employees as well as support to COVID-19 related activities chargeable against the Unappropriated Surplus End of Year 2019, Salary Savings from Vacant Positions, General Fund Continuing Appropriation and 20% Development Fund Continuing Appropriation, this city.

SECTION 2. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, Manila, through the City Budget Officer of Ormoc and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;

RESOLVED, FURTHERMORE, to furnish copies of this Appropriation Ordinance, one each to the City Mayor Richard I. Gomez; the City Administrator, Mr. Vincent L. Emnas; the City Legal Officer, Atty. Josephine M. Romero; the City Budget Officer; the City Accountant; the City Treasurer; the HRMO; the City Auditor; the City Local Government Operations Officer-DILG; and other offices concerned;
