PREFATORY STATEMENT

WHEREAS, the Sangguniang Panlungsod was in receipt of an urgent Endorsement Letter from the City Mayor's Office dated December 23, 2020, respectfully requesting for a Supplemental Appropriation in the total amount of ELEVEN MILLION SIX HUNDRED FIFTY-FIVE THOUSAND PHILIPPINE PESOS (PHP11,655,000.00) for the grant of the Service Recognition Incentive (SRI) for qualified regular and casual employees of the City Government of Ormoc as per Budget Circular No. 2020-6, dated December 22,2020;

WHEREAS, the provision of the SRI is anchored on the authority granted by law per Section (17) (iv) of Congress Joint Resolution (JR) No. 4 dated June 17, 2009 stating that the President upon the recommendation of the Department of Budget and Management (DBM), is authorized to update the Compensation and Position Classification System (CPCS) for civilian personnel and Base Pay Schedule for military and uniformed personnel, as well as the policies on and levels of allowances, benefits and incentives applicable to all government personnel;

WHEREAS, Section (4)(h) of JR no 4 authorizes the grant of incentive to reward an employee's loyalty to government service and contribution to the agency's viable existence;

WHEREAS, the Department of Budget and Management issued Circular No. 2020-6 providing for the guidelines on the grant of the one-time SRI to government employees for the Fiscal Year 2020;

WHEREAS, government employees deserve to be rewarded to recognize their collective and unceasing participation and invaluable contribution to the Administration's continuing efforts toward the establishment of streamlined government processes and more responsive delivery of public services;

WHEREAS, the amount to be received by each qualified employee is computed at TEN THOUSAND PHILIPPINE PESOS, subject to pro-rata relative to the number of months in the service in CY 2020;

WHEREAS, the Human Resource Management Officer submitted a summary of the total number of officials and employees who are qualified to receive subject incentive, the breakdown of which is as follows:

APPROPRIATION ORDINANCE NO. 034 (Series of 2020)

AN ORDINANCE REVERTING THE SALARIES AND WAGES & OTHER COMPENSATION OF VARIOUS OFFICES AS PER ATTACHED SCHEDULE IN THE TOTAL AMOUNT OF ELEVEN MILLION SIX HUNDRED FIFTY-FIVE THOUSAND PHILIPPINE PESOS (PHP11,655,000.00) AND RE-APPROPRIATING THE SAME FOR THE GRANT OF THE SERVICE RECOGNITION INCENTIVE (SRI) FOR QUALIFIED REGULAR AND CASUAL EMPLOYEES OF THE CITY GOVERNMENT OF ORMOC.

BE IT ENACTED, by the Fifteenth Sangguniang Panlungsod of Ormoc in Regular Session assembled, that:

SECTION 1. CY 2020 GENERAL FUND SUPPLEMENTAL BUDGET. The total amount of **ELEVEN MILLION SIX HUNDRED FIFTY-FIVE THOUSAND PHILIPPINE PESOS (PHP11,655,000.00)** Is hereby reverted and reappropriated for the grant of the Service Recognition Incentive (SRI) for qualified regular and casual employees, to be taken from the reversion of Salaries and Wages & other Compensation of various Offices – as per attached schedule.

SECTION 2. <u>EFFECTIVITY.</u> This Appropriation Ordinance shall take effect immediately upon its approval.

RESOLVED, FURTHER, that sufficient copies of this Appropriation Ordinance, together with all supporting documents thereof, be submitted to the Honorable Secretary of Department of Budget and Management, and the Regional Director, Department of Budget & Management, Tacloban City, for review purposes;
