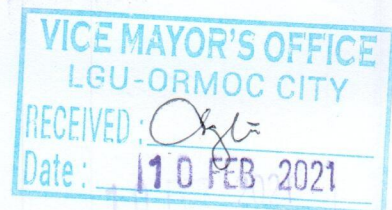

WHEREAS, the Sangguniang Panlungsod was in receipt of an urgent endorsement letter from the City Mayor's Office (CMO) dated February 8, 2021 requesting the amendment of Appropriation Ordinance No. 002, series of 2021 to correct the account source as per CDRMC Resolution No. 01, series of 2021;

WHEREAS, this Sanggunian passed Appropriation Ordinance No. 002, series of 2021 entitled:

BE IT ENACTED, by the Fifteenth Sangguniang Panlungsod of Ormoc in Regular Session assembled, that:

SECTION 1. The Title of Ordinance 002, series of 2021 is hereby amended to read as follows:

SECTION 3. EFFECTIVITY. This Ordinance shall take effect immediately following compliance with the publication and posting requirements in the Local Government Code of 1991.


